

These are 194 readable stones. There are 8 stones with numbers or initials and one reads: 1839 \_\_\_\_\_ Hinshaw. There are a good many rocks left that mark graves and several stones that all markings are gone. Its the first cemetery the editor has seen with headstones facing two directions. Most of the older stones face the old Greensboro Road and Peter Dick's stone is one of those closest to the Road. The front row and those next to the church are facing towards the church and backing the older stones. Joel Ingold's stone is marked: Lauder, Fayetteville, N.C., perhaps made by them.Ed.

## NEW SALEM

"The north part of the land on which this village stands was entered in 1792 by Joseph Hill, and afterwards conveyed by Hill to John Dennis, and by John Dennis to William Dennis.

In 1815 William Dennis conveyed to Jesse Hinshaw and Joseph Elliott, in trust for the Society of Friends, two acres of land for a meeting house!

Register Deeds, Randolph County, N.C. Book 84-page 506

" To have and to hold the said lot or parcel of land with all the rights, privileges, emprovements, appurlenances and hireditaments thereunto belonging or in any wise affertaining to the said parties of the second part and their successors as Trustees of and for the Methodist Protestant Church in trust for the sole and seperate use benefit and advantage of the Methodist Protestant Church, and to use or uses as the said Church shall appoint, and the said parties of the first part for themselves and their successors in office forever that they are seized of said lands in fee and hath right to convey that they are seized of said lands in the same in fee simple, and that they will warrant and defend the title to the same against the legal claims of all persons whatever.

#### History of New Salem Methodist Church

Compiled and written by

The history of New Salem Methodist Church dates back to 1815.

It was originally started by the Society of Friends or Quakers. When William Dennis conveyed to Jesse Hinshaw and Joseph Elliott, in trust for The Society of Friends, a tract of land on which to build a house of worship.

The first building was a log structure, some time later it was weatherboarded, then finally torn down and replaced with a frame building.

The first church stood near the northeast corner where the cemetery now is.

For seventy four years these two buildings served as places of worship for the Friends. Around 1889 the Friends at New Salem united with others of their faith in another community and their church at New Salem was sold or given to a group of Methodists who were trying to organize a church at that time.

It is said there was one condition the Friends required of the Methodist group. That the cemetery be kept in order, and speaking of the cemetery, let me say here, that there are some interesting markings on some of the sompstones used for headstones in this cemetery.

There is one with the date 1800 No. 10. Another dated 1820 and the letters J. H. One dated 1820 No. 10 J. D. One dated 1823 M. D. Also the following: 1825 No. 28., 1825 No. 30 L. D., 1827 No. 41 P. E., 1827 No. 32 L. D. What these strange inscriptions mean no one seems to know. But personally I wonder if these could be graves of slaves or perhaps Indians?

The oldest graves I have found, with names inscribed, is Joseph Julian who died May 11, 1813, and William Victory May 11, 1817. Peter Dicks, who is reputed to be one of the founders of the town of Randleman, is buried in New Salem cemetery. His stone bears the date Dec. 1843. There is on record at this time (1968) 195 marked graves in the cemetery but there are scores of unmarked ones. The history of the cemetery seems to be much older then the history of the church. (Ed. note: Another section of this Quarterly Mrs. Wood has listed the cemetery stones.)

In the year of 1894 the Methodist protestants began plans to build a new church. Mr. James (Jimmy) Hayes of New Salem gave them a strip of land adjoining the church property on which to build the church.

At this time, we are told, they were holding their services in the school house, which stood near the place where Mr. and Mrs. Jim Trodgons home now stands.(Ed. between New Salem and Randleman southerly direction). Just how often they had services then, we cannot say, perhaps not very often, as the old circuit rider preacher usually had to travel on horse-back or in a buggy and some times he walked. The roads in those days were rugged, the winters cold, and many times the snows were deep.

There were no comfortable parsonages near by, for the preachers to live in, and they would travel on Saturdays, some times many miles, and spend the night with one of their members near the place where they would preach on Sunday.

Of course we cannot be certain who the preachers were for these first services

held in the school house, but from an old Methodist protestant Journal I find that some of the preachers filling the pulpits of nearby churches of the same denomination were the Rev. William M. Pike, who was at the Randleman church in 1890-1891. Rev. C. A. Cecil was there in 1893 and Rev. W. F. Kennette was there in 1895. It is very probably these men were the very first preachers to preach at New Salem church at the time of its organization.

The new church building was completed in 1895 and the Rev. E. A. Plyler was assigned as the first regular pastor of the new church, November 1895.

Some of the Charter Members of the New Salem M. P. church were, Frank Bischer, David Fogleman, E. L. Hayes and Robert Taley.

The church was a one room wooden structure. There were no class rooms, all the people, young and old, met in the sanctury for their Sunday School sessions. Some time later the classes were divided by drawing a curtain between them. There was a large wood-burner stove near the center of the church that furnished heat for the building. There was a lot of trees in the yard which served as hitching posts for the horses.

The Annual Conference of the Methodist protestant church always met in Nov. each year. They did not have District Supt. then as we do now, but a President of the Conference. It was considered quiet an honor to have the president of the Conference to visit your church, which he did occasionally.

Rev. W. A. Bunch was President of the Conference at the time New Salem Church was organized.

The Randleman Circuit was set up in 1895. It consisted of the following churches: Mt. Lebanon, Worthville, Bethany and New Salem. These made up what was called the Four Point Circuit.

Twenty five years later in 1919 Bethany church was taken off this circuit and put on the Randolph charge and Level Cross church was put on the Randleman circuit.(Ed. Old M. E. church 3 miles north of New Salem.) The churches continued in this connection for thirty years then Mt. Lebanon church requested in 1949 to be removed and be made a two point charge with Old Union Methodist church.(Ed. MT. Lebanon Methodist Church is in Randleman and Old Union Church about six miles west of Randleman. Both are older then New Salem and will be featured in future i sues of the Quarterly.) Since that time the Randleman Circuit has remained a three point chrage with Worthville, New Salem and Level Cross Churches. Rev. G. B. Ferree was the pastor at this time.

The Rev. Mr. Plyer left the charge in Nov. 1897 after serving two years. He was followed by Rev. P. C. Battle, who also served two years, from 1897 to 1899, Rev. J. F. Austin came in Nov. 1899. He was in the work one year. Rev. S. E. Lucas followed him in Nov. 1900. He served three years. Rev. J. H. Bowman was next, he came in Nov. 1903 and stayed two years. Rev. J. R. Hutton served one year from 1905 to 1906. Rev. W. A. Bunch came in Nov. 1906 and was serving in his third year when he died in 1909. Rev. W. C. Hammer supplied the balance of that year. Rev. T. H. Matthews was assigned to the work next and served two years. Rev. J. B. O'Bryant was the next pastor. He came in Nov. 1911. He was perhaps the most beloved pastor to serve the church. He was on the charge seven years, and was wanted longer but he felt that he had fulfilled his mission at New Salem and should go elsewhere. He left in Nov. 1918. Let me say here that during Rev. Mr. O'Bryant's pastorate a parsonage was bought for the charge. in Randleman and still serves as the parsonage. He may have lived in it for a few years but during part of the time he served the work he lived in New Salem, in the house now owned by Mr. and Mrs. C. R. Wood, and where they live. It was used several years for a parsonage. (Ed. Mr. and Mrs. Wood came to this parsonage to be married while the pastor was living there not knowing that one day they would own and live in the house.) Rev. E. G. Lowdermilk followed Mr. O'Bryant in 1918. He served one

Year. Rev. J. A. Ledbetter came in Nov. 1919 and was at New Salem two years. In the 1919 Conference Bethany Methodist church was taken off the charge with New Salem and Level Cross was added.(Ed. Bethany Methodist church is an old church and is east of New Salem about four miles.) Rev. H. S. B. Thomson was assigned to the charge in Nov. 1921 and served two years. Some time during his pastorate the parsonage was destroyed by fire.

Rev. J. H. Trolinger, a young minister, was assigned to the work next, in Nov. 1923. He and his young wife lived in Worthville, as there was no parsonage for them. But they spent much time in the planning and erection of a new parsonage, to replace the one burned. It was finished about the time he left the work a year later to resume his studies at Westminister Seminary. Rev. W. H. Neece moved into the new parsonage in Nov. 1924 and served four years.

Rev. T. A. Williams came in Nov. 1928 and served four years. Rev. J. B. Trodgon came in Nov. 1932 and stayed five years, until 1937. Rev. C. L. Spencer followed next and was at New Salem two years, leaving in 1939.

The year of 1939 marks the unification of Methodism. At this time the word "Protestant" was dropped from the church name. Being united with the Methodist Episcopal Church, South, and the Methodist Episcopal Church, the church is now known as "New Salem Methodist Church"

Rev. J. R. Anderson was the first pastor of the New Methodist Church. He came on the work in Oct. 1939 and was serving in his second year when he died on July 7, 1941. As you will notice the annual conference has been changed now from Nov. to Oct. Rev. Robert Stamey, a young ministeral student from Duke University, was sent to finish out that conference year.

Rev. Y. D. Pool came in Oct. 1941 and served one year. Rev. J. H. Trolinger came next and served three years, from 1942 to 1945. Rev. Mr. Trolinger was the only pastor, in the history of the church, to make a repetition, coming back after having pastored the church eighteen years before.

Rev. J. C. Gentry was assigned to the charge next, Oct. 1945 and he served two years. Rev. G. B. Ferree followed next, he was on the charge three years, from Oct. 1947 to Oct. 1950. It was during Mr. Ferree's pastorate that Mt. Lebanon- Old Union charge was set up in 1949. This left Randleman Circuit a three point charge. Churches on the charge were, New Salem, Level Cross and Worthville.

In 1948 plans were made and construction started to build a new brick veneer church at New Salem.

Roy Hayes gave gave to the church a small strip of land adjoining the church property. This gave them ample room to turn the old church around, and convert it into class rooms. So only a new santuary was built.

Thoase serving on the building committee, with the pastor, were W. V. Bisher, Mike Fogleman, R. S. Hayes, Talmage Daniels, M. C. Henley, Cliff Hinshaw, Jesse Skeen, Bernard Richardson, Gene Hinshaw, R. F. Ward and Fuller Russell.

Rev. J. P. Rutledge came to the charge in Oct. 1950 and served two years. It was during his ministry that the new church was completed. He was followed in Oct. 1952 by Rev. Claud Young, who was pastor for four years.

On June 27, 1954 the laying of the coner stone and the dedication service was held. Rev. J. P. Rutledge, a former pastor, preached the dedication sermon. Rev. M. T. Hipps District Supt. of the Thomasville District, together with the pastor Rev. Young, and Rev. Rutledge with another former pastor, Rev. G. B. Ferree, took part in laying the corner stone.

In January 1955 the official board of the church voted to start a building fund

for the purpose of building an educational building, as the class rooms had become over crowded and there were not enough rooms to accomodate the Sunday School.

A finance committee was appointed to look after the building fund program. This committee was; Gilbert Christenberry, Treas., Leard Brown and Mrs. Alta Johnson. One Sunday in each month was set aside as "Building Fund Sunday." The fourth Sunday in each month was chosen.

Several months later a building committee was appointed to start working on plans for the new building. This committee was; John Wood, Chairman, C. O. Hayes, and C.W. Henley. The first steps taken in this new project was to have a deep well drilled and pump installed. This was done in 1956. Rev. Mr. Young left the work in Oct. 1956.

Rev. Don Bridges followed Rev. Young. He served two years. His second year was a short term as the Annual Conference voted at their 1957 session to change the time of meeting from Oct. to June.

By the middle of the year 1957 the church was about ready to launch out in a new building project. John Wood donated to the church the land on which to build the new educational building, to the right of the church, and land for a driveway. The contract for the building was given to Coltrane and Graham of High Point, N.C. Sept. 1957. The contract price was \$24,600.00 and this called only for the main floor of the building to be completed. The basement was to be finished later. This price did not include plumming, heating or wiring. These were seperate contracts. Tom Henry Daniels was appointed overseer of the construction. Oct.2, 1957 the first dirt was moved making ready for the foundation of the building. By April 1958 the new educational buildings main floor was completed.

On Easter Sunday April 6, 1958 the building was formally opened, when the two oldest members of the church, Mike Fogleman and Walter Bischer, cut the ribbon across the door leading from the sanctuary into the building. Then all the people present went through to view and admire the beautiful class rooms. But it was not until June 22, 1958, on the annual Home Coming Day, that all the furnishings were in and the rooms made ready for use by the classes.

Rev. Mr. Bridges left the work in June 1958. Rev. Vandry Williams was next. He served three years, leaving in 1961. He was followed in June 1961 by Rev. Coy L. Brown, Jr. He was on the work two years and left in June 1963.

In 1962 the basement of the educational building was completed and furnished. Early in 1963 all indebtedness was paid and it was formally dedicated on May 5,1963.

Dr. Ralph Taylor, District Supt. of the High Point District, had charge of the dedication service.

Rev. Cameron M. Dodson was assigned to the charge in June 1963, and then in June 1964, the Rev. Lee Roy Hunt, was called as an Associate pastor. In June 1966 both Rev. Dodson and Rev. Hunt left the Circuit and was followed by Rev. Ervin S. Cook in June 1966. It was during Rev. Cook's pastorate that the Methodist Church joined with the Evangelical United Brethren Church, April 23, 1968. The special service of this historical event, officially consummating the union, took place in the arena of the Dallas Memorial Auditorium in Dallas, Texas. At this time the church name was changed from Methodist to the "United Methodist Church."

Rev. Mr. Cook left the charge in June 1968 after serving two years. He was followed by Rev. H. B. Hyatt.

# ISAAC FARLOW'S STATEMENT OF REVOLUTIONARY EVENTS

Isaac Farlow aged 85 the 10th of October 1852, son of Nathan Farlow who came from Chester County, Pa. Captain William Clark lived about one mile west from Bells Mills in Randolph and was over 75 years old when he died which was 15 years ago -- he had brothers Thomas, Edward, Samuel, Joseph, John.

William Clark was a Presbyterain before the war and acted clerk in that church at Union, N. C. 3 miles from Bells Mills, and would shed tears in giving the out hymns, and remained a Presbyterian until after the war was over and told Isaac Farlow that war and bloodshed and Negro slavery was inconsistent with the Gospel and changed him.

Several years after the war he joined the Society of Friends--he was for a long time under concern of mind and on Saturday attended a meeting at Centre Meeting House of Friends in Guilford, at a Quarterly Meeting and Daniel Haviland from the north attended and preached -- after the sermon had closed he rose and walked foward and spoke to the meeting and said he had a desire to become a member of that Religious Society--he had for some time before used the plain language--Issac Farlow was present--(this was in 1800)

and it was concluded for two to rush to the door and stave it down and take the men before they could get their guns--- and Veech volunteered to go with Clark and they started and getting near the house Veach flinched and gave back and declined and they returned to the company close by and Grogan then offered to go and he and Clark started and they went up to the door and before they reached the door Grogan gave back and Clark kept on by himself and stove the door off the hinges halfway across the house and seized a man in bed and rushed him to the fireplace and says I have got hold of Mr. Still and the man said no it was not--and Clark jolted his head a few times against the mantle peice and Still said don't abuse me---and Clark said tell me no lies and I won't and then Still did not deny his name any more, and Clark knew him by the light.

And Clark said you had pretty fun killing Henry Johnson and Still said he was dead when I shot him (this was evidence that he killed him.) and Col. Dougan and his Company forthwith followed Clark and seized Elrod and the other man before they could get their guns- and when Still said Johnson was dead when he shot him Elrod said Still don't go to death with a lie in your mouth --- and Col. Dougan's company held a sort of court martial and decided to shoot them and next day took them half a mile from his mothers and shot them both. Elrod behaved calmly, but Still turned and twisted and could not be kept quiet. Elrod was shot under the arm----for Isaac Farlow saw Wm. Durnell wear Elrods waistcoat after with a patch over the bullet hole ---- Elrod quietly submitted to his fate and distributed some of his clothing, and Elrod and still were left where they were killed.Col. Dougan had before this been taken prisoner by the Brittish and conveyed to a Prison ship at Wilmington, N.C. and his mother Mary Dougan and Matty Bell wife of William Bell went to the prison ship from Randolph to see Col. Dougan and they were refused the liberty of seeing him --- and along time afterwards Col. Dougan was sentenced to be hung off the Prison ship and he was blindfolded to be swung off, and Elrod and Michael Robbins were present and begged him off, and he was discharged and sent home, and shortly after Isaac Farlow saw him very much emaciated walking the mill yard and Bells Mills<sup>2</sup> and bemoaned and sighed much and was very melancholy and he was so poor his legs did not near fit his long stockings, (he wore shorts.)

The Tories came one night to Wm. Bells to kill him and his house was barred and they could not get in and Bell put his head out at a window to shoot some of them with a pistol and one near struck him with a sword and his wife screamed and hollered and called a negro to run to Joseph Clarks(a brother of Williams) for the Lighthorse and one of the Tories thought he saw a negro run and the Tories left---and shortly the Lighthorse did pursue and Col. Dougan along and found the Tories down Deep River above the mouth of Webbs Creek<sup>3</sup> and one by the name of Franklin mounted his horse and Col. Dougan pursued him horseback and levelled his gun and shot Franklin and he fell and begged to be helped up and Clark dismounted and helped him and always said that it was a sure work of a coward to crow over a man in his power---poor Franklin died. Col. Dougan was awhile confined at Wilmington before he was placed in a prison ship and used to say that every woman he saw his heart would rise to his throat fearing it was Franklin's wife come to have him hung.

When Col. Dugan and others took Elrod and Still, Elrod and Dougan sat on the side of the bed and talked a long time and Elrod urged upon Dougan to recollect that he saved him from being hung at the prison ship and Dougan replied to Elrod that for anything he ever did to him he could freely forgive him, but for Elrod having killed Henry Johnson he must be put to death. Isaac Farlow knows nothing of the families of Elrod and Still---Jo. Clark once shot at Michael Robbins. (Farlow statement)

Sometime after Elrod was killed Capt. Wm. Clark went to Edward Thornburghs in Randolph and as he entered the door Michael Robbins rose and met him and offered Clark his hand and Clark took it and then they sat down and had a long talk about the whole matter. Clark was mowing near Thornburghs and broke his scythe and stepped over to Thornburghs to mend his scythe and found Robbins there by accident---Robbins was a bold and fearless man and often remarked before he left he feared nothing he had ever done except the affair of Johnson's death.

Joseph Clark lived near Bells Mills and married a Smith a family of Tories. A day or two after Col. Fanning and Company had killed John Bryant 2 miles South--west<sup>4</sup> of Bells Mills Jo. Clark and others pursued and found a Tory running and rode after and overtook him and he got behind a sappling and there turned about and John Dougan snapped at him a few times and J. Clark rode up and fired and the Tory sank down as dead and Captl. Clark then rode and directed them not to leave the man till he was dead but they all went off and the Tory got up and ran off. Near Uwharrie Jo. Clark was after riding hard with Wm. Millikan and Clarks Horse flew the way and struck his head against a tree and in 2 or 3 days he died--- he left a widow and several children and all are now dead. His widow was afterwards married to Benjamin Mendenhall a member of the 'Society of Friends.

John Clark was Capt. Wm. Clarks youngest brother and took an active part in the war and was more bold and daring then any of them and resolute. Samuel Clark was their father and came from Ireland.

Elrod was only occasionally with Col. Fanning. Col. Fanning and company had hung a Whig(his name is not known) when returning from killing Bryant for the Whigs had before hung a Tory on the limb near Browers and Spinks named Isaac Jackson and Fanning had threatened he would hang 5 Whigs on the same limb for every Tory the Whigs hung, but Fanning mistook the limb and hung the Whig on another limb near it ---- and the limb was hacked off where the Whig was hung near a short turn in the road when the Lighthorse rode up in pursuit of Fanning after Bryants death and found the Tories laying out the corpse of the Whig and they ran off and it was one of these whom John Dougan snapped and Jo. Clark shot when he sank down and after run off.

Isaac Farlow has seen the hack in the limb where . Fanning hung the Whig.

John Bryant was killed 2 mile south of the New Market where Joseph Newland lives --- at his own house --- Stephen Walker was a bloody Tory and was with Fanning when Bryant was killed. Bryant must have been on a parol, and had a Captains commission on the Whig side (the he had been a Tory) for when he was attacked in the night in his own house and required him to surrender he asked what they would do with him if he did not surrender and they answered they would parol him and Bryant replied damn you and your parol too; I have had one and I will never take another, and Fanning spoke and said my life for his if Walker don't kill him. Fanning, and company in going to Bryants missed their way and got Betsy and Alcey Horlin<sup>6</sup> 2 daughters of Stephen Horlin to go and show them Bryants house and these girls who were forced to go begged of Bryant to surrender assuring him it was Col. Fanning who was there, but Bryant would not believe Fanning was there and cursed Fanning and the whole of them. And one of the girls was about to go in, for Bryant opened the door to let her in and Walker caught her by the coat and pulled her back and swore he wwas going to protect Bryant. After many hours of resistance, Bryant opened the door and stepped out on the step and said Gentlemen I surrender ---- and he was forthwith shot down not known by whom and he fell back against his wife who was at his back and she was raising him up and another man stepped up and shot him in the eye. Fanning threatened death to any who would give the alarm before daylight after Fanning rocking himself awhile in the cradle,

and straightway Richard Isaacs who lived at Bryants went to Nathan Farlows and he and his wife Ruth went to Bryants before day and Nathan stayed off a little and Ruth went up and passed the dead body of Bryant, finding his head in the house and feet and legs outdoors. Shortly Nathan went up, finding all the party had left, and by daylight they had Bryant laid out, and at sunrise Isaac Farlow went himself and saw the corpse and the two bullet holes. No ball went through him ----the first shot was in his breast. The Horlin girls said the firing was with rifles.

Fanning on his way to Bryants, pressed Benja Millikan and Joshua Lowe with him as pilots to Col. Collier's house --- Collier was at home asleep and had his horse at the door eating out of a mortar and Benja Fincher with a gun keeping watch on a pile of rails; when Fanning approached Fincher hailed and Fanning made Millikan and Lowe answer Fincher kept hailing and they answering till Fanning came up and some of them fired guns at Fincher and he had a tight vest on and the bullets glanced and he came where Bryant was a corpse and Isaac Farlow saw the next day the place on the vest where the bullet glanced ---- when Fincher was fired upon he hopped off the rail pile leaving his musket and ran. The firing waked Col. Collier and he rose and cried out," parade boys, parade," and this checked Fanning a little and this allowed Collier time to mount his horse andescape. Col. Collier was county surveyor and was not capable and brought William Clark from Virginia to do the business; and Clark found where the vacant land was entered, Nathan Farlow, Horlins and others, and after Clark employed Linder to sell his lands and Ralph Lowe, Jno. Bryant helped Clark to survey; and Nathan Farlow had to pay a fat stear and gold for his land, and after Nathan Farlow owned all Lowe's land and Bryant's land and Collier's too, and Isaac Farlow now lives on the Lowe land. N. Farlow thought very hard of their near neighbor Lowe and Bryant for assisting Clark in taking their land away.

Fanning had old William Millikan's house burnt and Collins and Col Thomas Dougan's, and all this was done the same trip, and he had killed Col. Balfour on his way before he got to Collier's, and Millikan's house also burnt before and the barn, and Millikan's son Benja and Joshua Lowe he took as pilots.

Wherever Fanning found the man and killed him, he did not burn the house.

Nathan Farlow has drafted and declined going and was fined 10 pounds and Genl. John Hamilton was fine collector and he took Farlow's horse to Martinville7 and sold him for Farlow's fine.

#### ISAAC FARLOW

Thomas Farlow came from England to Virginia with his wife and daughter Ann in the "Ship Ann2 and were living close to Jamestown, Virginia in 1623.He was in the House of Burgesses in 1631-32. About the year 1758 John Farlow, descendant of the fourth generation from Thomas came to North Carolina with the families of Carters and Harlans, from Penn. where some of the Virginia family had moved. The three families had intermarried, Ruth Carter married Nathan. • Farlow, a grandson of John, and became the mother of all North Carolina Farlows. Margaret Farlow, a daughter of John, was married to William Harlan and stayed in Penn.

Michael Farlow, who married Mary White in Old Swedish Church in Wilmington, Del., came to North Carolina with his father John.

Michael was the father of William, George and Nathan, Nathan Farlow married Ruth Carter and had 11 children, one Isaac Farlow.

Ruth Carter Farlow came from Chester County, Penn, with her family and a group of other families and settled with her family on a small strip of land later cut from Orange county to make Guilford and Randolph and was about a mile south of Marlboro Friends Church. Ruth and Michael are buried in Marlboro Church.

# NEW SALEM LODGE NO. 209 THE GRAND LODGE OF ANCIENT, FREE AND ACCEPTED MASONS OF NORTH CAROLINA

Masonic Lodge No. 209 of New Salem, N. C. was chartered on December 7, 1859. The meetings were held in a two story, eight room, wooden house, that stood where the present brick store, between the Oscar Hayes and Roy Hayes house's are, on the street in New Salem.First officers were: L.C. Underwood, E.H. Lineberry, S. Lineberry.

The lodge was moved to Randleman in 1880 and the name was officially changed to Randleman Lodge No. 209 on December 8, 1880.

The lodge home was a building standing when the lodge began to use it for meetings. It had four large rooms upstairs and four down stairs, with fireplaces. E. P. (Pierce) Hayes may have owned the house before and during the time the lodge met but he owned it later. After the lodge moved to Randleman Mr. Thayes rented the house for a dwelling, then it was moved down Noami street, back on the hill facing the present Shaw street and later it caught fire and burned.

According to records in the Masonic office in Raleigh, N.C. this lodge apparently had a rather stormy career. The records show that it forfeited its charter in 1887 but had it restored in 1888. It was active again until 1895 when it again surrendered its charter. This time it was officially restored on August 4, 1896, and was active until January 31, 1912 when the charter was arrested by the Grand Lodge. When a lodge gives up its charter for any reason, the Grand Lodge takes all books and records. There are two minute books and several cash books or ledgers in the Raleigh that was turned in when the charter was arrested the last time.

Four of these books have been examined The oldest date found was Dec. 27, 1899. One page with the above date and the following information was listed.

The register of North Carolina mail routes for 1830-34, contain a reference to mail route contract No. 2157, for a route from Chapel Hill (by way of Clover Garden, Lindleys Store, Snow Camp, Long Stills, Troys Store, Hone Factory, New Salem, Walkers Mill, Gardiners Store, Hunts Store, Brumels, Dobsons Store, Lexington and returning by way of Lexington, Fair Grove, and LaCrange to Gardiners Store which was a distance of  $84\frac{1}{2}$  miles, and was let to John Long of Longs Mills, for delivery of mail once a week.

North Carolina mail route registers for the years 1830-34 shows New Salem was on mail route No. 2164 from Leaksville to Asheboro, N.C. overwhich distance of 62 miles the mail was carried by William Dennis, Jr. twice a week.

A post office was established at Walker's(sic) Mills(sic), Randolph county, N.C., on February 9, 1832, with Jesse Walker appointed as its only postmaster. Walkers Mill post office was discontinued on October 18, 1836. Ed.- Walkers Mill(as the place is still known, was once Fells Mill, is approx. 2 miles west of New Salem.)
