

I do want to thank every one for their patience in the lateness of the last year's Quarterlies, with only one exception, and that is straightened out with the kindness and understanding of the member, most have understood and renewed their membership.

I feel that I should write so that each would understand our problems and get to know us so that you will understand when the Quarterlies are late, mistakes are found and then you can decide if you want to spend your money for membership with that in mind.

We do not have a professional genealogist /the group-town-county, perhaps! Mr. Calvin Hinshaw is a member of our Society and has been kind to help us, in general, check some material but he has a regular job and his own searching and work to do. He is compiler of the Randolph County 1815 Tax List, finishing a book of The Hinshaw's of Randolph County and many other works. Mr. William Perry Johnson, Editor of The North Carolina Genealogy has been most kind to us but mostly it is————or has been one person, collecting, material, typing (when they can't), running the material off, getting the pages together, mailing out and delivering in town (and outside.) All this is done on the dinning room table, and by emptying my husband's desk, files, chair and lots of times, walking space.

I have three children, a son married with a granddaughter five months old and living in towh, a daughter in college in Greensboro and a daughter in Junior High here. I am active in my church work-which comes first, and for every time I get the material out to work, I have to collect it all and pack it up again. With illness, and other assorted problems, we just cannot do things as just should be done.

We love the work and hope to continue a long time, but it will have to be second to our family and plain old housework. We, aso, have to pay for ourselves to be a part of the Society, for the main purpose of it is to build a Museum and preserve St. Paul Church and other locations. Any type of work such as this is really a labor of love as you have heard many times. Our trips to Asheboro, our hours of work, our exchange of letters with members are all on our own.

So, beginning immediately, all Quarterlies that are bought seperate and mailed out and the person is not a member of the Society will be \$1.50. Members may buy as many Quarterlies as they want, even back issues at \$1.00 and we will be glad to mail them at our Library rates, for you.5¢ per issue. So if a member wants a Quarterly mailed and writes to us send  $5\phi$  or a stamp for each issue you want mailed. If you have sent \$1.00 for the four issues of this year, we have a record and will honor these but no more orders after this date. No extra material will be sent with the \$1.00 issues, as printing has really gone up.

Quarterlies will still be \$1.00 in town, at our stores that sell for us, as persons can walk by and pick them up and we hope for new members. All free copies will be discontinued, excepting our exchange and honorory members.

Beginning in June, with the June 1969 issue we will still be a quarterly publication but will be, Spring, Summer, Winter and Fall and hope that we might get the issues out by March-June-Sept.-December, but that way we will not be tied to an exact date.

We appreciate our members, and hope that this will help us in continuing to issue our Quarterly. ----- Ray Cashatt, Editor

#### PRESIDENT'S PAGE

Dear Members,

Things have been quiet, as usual since the fall. As you know we have not had any way to heat the Museum throughout the cold months and work there is impossible. However, this promises to be our last inactive winter. At the present we are having a furnace installed. When this job is completed most of the pressing renovation of our building will be completed. From now on we will be able to concentrate on the enterior.

Last fall we contracted to have the stained-glass window repaired although I'm sorry to report, that as yet, it hasn't been done. This work is being done with the Alton Culver Memorial Fund, at the suggestion of his widow, Mrs. Ruby Lassiter Culver. About the same time last fall there was some talk among a few of our members over the possibility of replacing the regular windows, which have been boarded up, as memorials to families whose parents, grandparents or other kin have connections with St. Paul Church. When the workmen come to repair the stained-glass window we will discuss cost with him so that the information will be available to anyone interested in a project of this sort. I would appreciate hearing from each of you concerning this.

Our exhibits continue to grow, though slowly. Our needs are great in this department. Many of you have promised family items, as soon as a safe place was provided, in which to keep them. So it gives me great pleasure to inform you that the lovely display case donated by Senior Scout Troop # 18 is now in use. We are in the process of moving several large display cases to the Museum, given to us by Mrs. Pauline Wertz of High Point, one of our members.

The Library and Publications Committees and the staff of the Quarterly have struggled to overcome the many problems of putting out a Quarterly. The major problem has been the inability to arrange suitable printing facilities but now the Historical Society is proud owner of an A. B. Dick mimeograph machine and the staff is hoping to catch up and stay ahead in the publications. Our genealogical files continue to grow but the committees need help from each member in collecting material. Will you begin, at home, by checking for old bibles with family information written in them, old church histories, family histories, old letters, anything that might shed interest and information of the people of our county and that we might print in the Quarterly. We are begging to build quiet a collection of old pictures and ask that each member keep on the look-out for them for our collection.

I would like to remind all of you that it is time to renew your membership. We really appreciate the friends that we have made these past three years. We hope that each of you will help in acquiring new members. Tell others of our Society and that it is not an exclusive group but the more members we have the more we can do in establishing the only Museum in Randolph County and preserving the brick church that is thought to be the first in our county. Our Quarterlies are fine but just one of our activies and barely pay for themselves and we need donations and dues so that we can continue in our work. If each member would try for one new member this year we would be showing progress.

We are pleased that several out-of-state members and visitors have been by this year. Rev. Sidney Robbins came by from Fla. on his way north and home.Mr. W. F. Mendenhall from Calif. stopped by on his way to Washington. We invite any of our members to come by and stop for a visit with us.

We are looking foward to an exciting and good year, will you, as a mamber, help make it one?

#### ROBERT N. HINSHAW FAMILY LINE 3000 East Bessemer Ave., Greensboro, N. C. 27405

Ed. note: Mr. Hinshaw is a member of the N. R. H. S. and we were very pleased that he made a trip from Greensboro to Randleman to bring us his material. Again, this is presented as material collected for family use and ask that you check all material before using it. We would appreciate any corrections and Mr. Hinshaw would so that our material may be correct. Vol. II No. I of our Quarterly gave Steed material we are beginning with NATHANIEL STEED.

MATHANIEL STEED, oldest son of CHARLES STEED and HANNAH RAINES STEED was born in Randolph county, May 3, 1812 and died at his home four miles south of Asheboro, November 20, 1880. He married:

2nd- JANE JOHNSON

3rd- SALLIE KEGGLE

No children were born to the second and third union, NATHANIEL STEED was a farmer and was known throughout the county as a friend to all in need. It has been said that he fed more people then any other man in the county. No one ever went to him in need but what they recieved assistance.

ABNER ADKINS STEED after his marriage settled on a farm four miles South of Asheboro. At the beginning of the Civil War he offered his services to the Confedercy and was stationed at Wilmington, N. C. from 1861 to 1864 from there he was transfered to Savannah and was there at the close of the war. After the war he returned to his farm. Seven years later he moved to Cedar Fall, N. C. Six years later he moved to Randleman, N. C. and purchased the lands of his Uncle Joseph Steed. He immediately began to improve and open up the land purchased which was located in the southern edge of Randleman. He sold off residence and business lots and was much interested in the development of that portion of Randleman known as Powhattan.

Co. d Aug. 27, 1964-88 yrs 4 mo 17 d bu Holly Springs. Her grandfather was Thomas Hinshaw b - d 1924 bu Holly Springs. Grandmother was Mary Barker b abt 1830 d 1922 also bu Holly Springs. #### MR. VILLIAM FRANKLIN MENDENHALL

#### THE REPORT OF THE PROPERTY OF

(Ed. Note: Mr. Mendenhall is a member of N. R. H. S. and has been generous in his gifts to the Society and with material for the Quarterly use. On his way to the Inaugural of his Cousin Richard Nixon as President, he came by Randleman and visited the St. Paul Graveyard and the Museum, with Mrs. Alton Culver, our Sec't. Mr. Menden is 'kin to two President's, the other-Herbert Hoover. He is, also, 'kin to most families in Randolph county. The: Allred's, Spencer's, Beeson's, Lineberry's and many others. We hope in future issues to print many of his lines and those of his family.

#### Statement of Rev. R. C. Allred-Relative To Family History

"Rev. "B. C."(Brazilla Caswell) Allred was William Franklin Mendenhall's mother's Uncle. His mother, Ida Martisha (Allred) Mendenhall was the daughter of William Franklin Allred and Martisha Caroline (Greene) Allred. Jerome B. Allred and William Franklin Allred and Rev. Brazilla Caswell Allred were brothers. They were the sons of Claiborne and Orpha Savina (Russell) Allred!

"The original of the following copy is in the possession of my cousin, Mrs. Elsie (Allred) Bland, Route 3, Rogers, Arkansas 72756 and she does not care if you copy it! William Mendenhall-March 16, 1969

("Below is a statement made by Rev. B. C. Allred, one of the brothers of Jerome B. Allred, December 20, 1922, relative to his family's history")

"My great grandfather, William Allred (Ed. note: Mr. Mendenhall's G G G Grfa) was born and reared to manhood in Pennsylvania. In early life he came to North Carolina and entered a large tract of land in  $l\frac{1}{2}$  miles from the intersection or the confluence with Deep River and Bush Creek, he built his home and settled down, where he lived to a good old age and reared his family. The time of his coming to North Carolina was about 1740 or 1750. His house was built within about 50 yards of the creek near a spring which came from under a large rock which was about 20 feet high and at least 100 feet long and 50 or 60 feet wide. There were an abundance of fine fish in the creek and river and lots of game in the woods, such as turkey, deer, wolves, and an occasional bear or panther.

My grandfather, John Allred, was born and reared in this same house. In the same home my father, Claiborne Allred, who was the youngest son of John Allred and Sarah Spencer, his wife, and my mother, Orpha Russell, settled when they first married and most of their family of seven children were born.

When the Revolutionary war came close, my grandfather, John Allred, shouldered his flint and steel rifle and fought for the freedom of the American colories to the end of the war. The fact of my grandfather's fighting against the Baldian and the anger of Col. David Fannen(Fanning), the leader of the Tories of pathizers, and he and his band of men went to my great grandfather's John, my grandfather, who happened to be at home, saw them coming, snature of gun and secreted himself in the attic and it so happened that they did not to the there and search for him. My great grandfather also saw them approaching the paraset of the house and lay down behind a large to the seen the rock and played around it many times, when I was a boy. He could be seen the crib door and let many barrels of corn run out of the two large hog cribs into the mud and turned their horses loose in the lot to eat and trample the corn into the red mud.

When they had eaten all they wanted them to have, they saddled them up and started on towards the western part of the county.

My great grandfather had a sprightly negro slave by the name of Kiltyre whom Fannen(Fanning) took with him. They first night they spent at the widow Kindley's near the river, who had a good many slaves. Kiltyre seemed so delighted with his new friends that Fannen(Fanning) told him to go down to the negro cabins and spend the night; but Kiltyre never got to the cabins, but next morning was at home where he remained until the old Master's death. In the division of the estate, Kiltyre Feel (?)(Fell?) to my grandfather where he spent the balance of his life. My grandfather and all the children thought a great deal of Kiltyre and built him a little home in the lane about 200 yards north of his own house and allowed him great many privileges that he did not allow his other slaves. Kiltyre spent many of his last years of his life in that little log cabin in the lane and from it his spirit went out into the Great Beyond. I never saw him since he died several years before I was born, but I heard my father and mother speak of him so often that I feel like I ought to know him.

My grandfather, John Allred, married Sarah Spencer, and settled about  $1\frac{1}{2}$  miles southeast of his father, where he reared a large family and lived to be about 97 years old. He and his wife and several of his children were buried in Trogdon graveyard across Deep River and south of his home. (Ed. note: We have just located an old Troggon Graveyard and hope to be able to get a reading of it soon. It is grown up and we have heard only a few stones left. Randolph county early Julians buried there) My father was the youngest of 18 children born to him and his wife. Four sons and eight daughters lived to be grown and most of them to a good old age. One daughter died when nearly grown. The other five died in infancy or early childhood. They all with Uncle William Allred and Aunt Vicie Dougan, sleep with their father and mother in the Trogdon Graveyard.

My father, Claiborne Allred, in early manhood, married Orpha S. Russell, daughter of Samuel and Leah Burgess Russell, and settled at his grandfather's old home on the hill near Bush Creek. There most of his children were born. Later he built about 1 mile north of his father's house. In that house, I was born, and in that house my father and mother both died. Also my little sister Elizabeth who died of measles when a little over 2 years old.

Seven children were born to my father and mother as follows: Minerva, Adeline, (who married Alfred F. Smith) who has been a widow nearly 42 years (as of 1922) William Franklin, who married Mattie Green (Mr. Mendenhall's grandfather and grandmother) (Her name: Martisha Caroline) and has been a widower about four years, Lovey Jane, who married Oliver P. Hays. She died in less then two years leaving a little girl, Ellen M., whom my mother raised. She married George A. Loughlin, who is now a Methodist Protestant Minister. She only lived 10 years after marriage and now sleeps in the Methodist Protestant cemetery at Cedar Falls. Mary Catherine, my third sister, married Mountaville Jones and has been a widow many years, Jerome Bonaparte who married Agnes Griffith of Indiana. She lived only a short time. He then came back to North Carolina and married Ann Gibson. She died in Arkansas , where he now lives.

My mother's father, Samuel Russell, and her mother Leah Russell, are buried at old Cool Spring Church in Randolph, also Uncle William and Aunt Betsy Russell, mother's brother and sister, who died young, are buried at old Cool Spring Church, which is about 8 miles north of Franklinville. That is the church where mother went to Sunday School and Class Meeting, when she was a girl, as grandfather lived near there.

Samuel Russell, my grandfather, was reared in Stokes County, North Carolina, on Dan River. He moved to Randolph County in early life and married Leah Burgess, and lived the balance of his life near Cool Spring Church where he now rests with his fine son and daughter.

My mother had three brothers and four sisters besides Uncle William and Aunt Betsy. George, who married my father's sister, Rebecca, moved to Madison County, Tennessee, and settled near Jackson, Uncle Howell married and moved to Obion County, Tennessee. Uncle Jerome V. married Martha Weisiger of Fayetteville and settled in Franklinville (Rand. Co.) and is buried in the Methodist Cemetery at that place. Aunt Polly Russell married John White and moved to Alabama, and settled on Tom Bigbee River. Aunt Rebecca Russell married John Bain and after his death moved with her children to E. Tennessee. Aunt Alva Russell went to her brother George's and married a Mr. Edwards and moved to Arkansas. Aunt Lovery Russell married Wesley Jones of Guilford County, North Carolina and then moved to Franklinville in old age where they both died and are buried in the Methodist Episcopal Cemetery at that place. Father's brother, John, married Polly York and reared a large family and died within a few miles of where he was born. Uncle Elishe(a) Allred married Barbara Spoons and first settled on B sh Creek near his father's but several years before his death moved about 15 miles below Franklinville on Deep River and is buried near Moffitt's Mill. He reared 12children.(Mr. Mendenhall's grandfather)

Uncle William Allred died in early manhood. My father's sisters married as follows: Vivie married Villiam Dougan and lived on Caraway Creek. The son died. Jennie married William Carter, who lived on Richland Creek in the southern part of the County. Sallie married William Free(Ferree) and moved to Hendrix County, Indiana, and settled near Brownsburg. Rebecca married my mother's brother George and moved to Tennessee, as stated. Matsy married Solomon Free(Ferree) and they lived and died across the River from Cedar Falls. Both died of typhoid fever in a few hours and were buried in the same grave at Giles Meeting House. Polly married Alexander Gray and they settled about  $2\frac{1}{2}$  miles north of Franklinville on the road toward Gray's Chapel. They were buried there. Uncle Alex was 84 and Aunt Polly was in her 97 year. Alib and Lavina never married but spent all of their lives near the place of birth and died of old age.

Four sons were born to Aunt Polly and Uncle Alex, as follows: Robert who died In Thomasville (Davidson Co.); Sandy, Dr. John and Dr. Claiborne. All of them left large families, except Dr. John. He is buried at Gray's Chapel, Randolph County.

(The above ends what Mr. Mendenhall's great-uncle, Rev. B. C. Allred wrote down in 1922 before his death in 1937.) (The following was added by one of his family)

"In case you may be interested in my father's futher background, I add the following: He was married to Sallie Janet Rives, daughter of Col. J. F. Rives and Elizabeth Marsh Rives, of Chatham County, North Carolina. His wife died Juné 3, 1881, leaving, surviving the following children; Sallie J., an infant died at or shortly after birth; Junius B. Allred, who died at about the age of 16, Linville H. Allred, now praticing law in Erwin, Tennessee, Caswell C. Allred, who died in his early manhood, and Jane Claiborne Allred, now residing in Philadelphia, Pennsylvania.

The father, B. C. Allred, was for more then 30 years an itinerant minister of the Methodist Church and died in November 1937.

Prior to his death he married a second time, and this time to Dora Kimball of Granville County, North Carolina. This marriage resulted in the birth of a daughter, Dora K. Allred, who is living with her husband, Dr. J. K. Bryan, and two children, J. D. Bryan, Jr. and Dora Allred Bryan, in Oxyford, N.C.

Linville H. Allred, died Oct. 1968, one of his sons, first married Myrtle May, daughter of T. C. May and Elizabeth May, of Spring Hope, North Carolina, by this marriage two children were born, Linville H. Allred, Jr., now living in Los Angeles, and Myrtle Rives Allred, also living in Los Angeles. Both of the above children are married and have three and two children, respectively, all minors at this time.

The wife of Linville H. Allred died in Erwin, Tennessee, on May 2, 1928. On October 19, 1937, he again married, this time to Ruth Howard, daughter of C. C. Howard, an attorney of Fayetteville, North Carolina. By this marriage they have one son, James Claiborne Allred, 11, now about 4 years of age.

James Claiborne Allred, the fourth son of B. C. and Sallie Rives Allred, married Alyse Ellis of Kittrell, North Carolina about 1902. They had two children, Sallie Rives Allred, who is married to Roy Richey, and lives at present in Clearwater, Florida, and Edna Allred, who is married to Joe Fuchs, and at present live in Durham, North Carolina(1950) where he is in school at Duke University. They have one son.

Mr. Mendenhall wrote: "The Lineberrys are 'kin to the Allreds and Beesons, and they are my 'kin, even the Pughs, Coxes and Johnsons. The Henleys and Jarrells are in my family. (These are some families we've written about.) My Aunt Marjorie (Stratford) Mendenhall's mother was Louisa Lineberry. She was my favorite Aunt. She has two grandsons that are doctors, Gerald Le Gwinn and James D. Le Gwinn. Aunt Marjorie died in 1962 and she and my mother and father are buried in the same plot, with her husband, my Uncle Percy Albright Mendenhall, in Greenhill Cementery in Greensboro, North Carolina!

#### RANDOLPH COUNTY, N. C. CONFEDERATE SOLDIER

The state of Indiana is bounded by the following states; Ohio on the east; Michigan on the north, Illinois on the west and Kentucky on the south.

Many persons migrated west, with many, many people from Randolph county, N.C. going to Indiana. Many places were named for the home-places that the people left, Blackford county, Ind. being just above Randolph county, Ind.

The very first settlement in the territory out of which Blackford County is composed and before the white man made his appearance, was by the Miami and Delaware Indians. 2560 acres of land was reserved for them on what was known as the Godfrey Reservation, this being in the north-east part of the county, but was relinquished years later and the Indians moved futher to the west.

Blackford County is located in the north-east part of the state with the legislature creating the county in 1839 and the county took its name from Judge Isaac Blackford, one of the pioneer judges.

Nicholas Friend was first sheriff and Eli Rigdon, Jacob Shroyer and Jacob Streeter were the first members of the board of commissioners. The first ballot box was the coffee pot of Andrew Boggs.

Some of the early settlers were; Benjamin Ressoner, Sr. (who made the first land entry, July 9, 1831) with his wife and five children, Peter Reasoner, Hiram Dille, Benjamin Reasoner, Jr., James Gadbury, Sr., Aaron and Archibald McVicker, Eli Rigdon, Adam Cunningham, James Romine, Daniel Geyer, Andrew Boggs, Aaron and Joanthan Hughes, Lair Runyon, Phillip Groves, Robert Stewart, Sr., Jacob Shroyer, Samson Dildine, Elijah Sims, Jacob Slater, Gilbert Townsend, Joseph Gettys, Jacob Stahl, John Ervin, Jacob Brugh.

The first real estate transaction on record in the Recorders office is that of Peter Olem and wife to Amiziah Beason, August, 1839. Beason didn't stay long on this land as he moved on to the Quaker Settlement of Fairmount, Grant county.

Dr. Ambrose Henley and Dr. Wilford Hess were two of the first doctors and John Ervin and Elijah Sims two of the first Methodist Ministers. Rev. Samuel Steel one of the first Presbyterian ministers.

There are five Revolutionary War Patriot's buried in Blackford county, John Mills, from S.C., John Twilbell, John Saxon, David Kirkpatrick, and Thomas Miles.

There are seventeen 1812 heroes; Andrew Blount, Peter Klemmer, Phillip Smell, Patrick Carmichael, Henry Clapper, Joseph Hinkle, Samuel, John Ferrin, Abraham Thompson, Thomas Markin, George Leffler, Abel Baldwin, John Waugh, William Hadden, John Heminger, and Joseph Neal.

The Confederate Congress on 17 Feb. 1864 passed the act by which the military age, previously 18 to 45, was extended to embrace all from 17 to 50. Those from 17 to 18 years of age, known later as Junior Reserves, were embodied into Companies in April and May, and in May and June were formed into Battalions, and later into Regiments, forming a total in N.C. of three Regiments, and one Battalion, which became the Junior Reserves! Brigade in Hoke's Division, Hardee's Corps.

The first Regiment of Junior Reserves was formed by the consolidation of the First and Sixth Battalions.

On July 4, 1864 the First and Sixth Battalions were organized into a Regiment with Charles Broadfoot, Colonel, and 4Walter Clark, Lieutenant-Colonel.Incidentally Lt.-Col. Clark was the youngest of that rank in the Civil War on either side, being 17 years of age. Col. Clark enlisted at the age of 14 as 2nd Lt. and Drill Master of the 22nd Inf. Regiment, having been at that time a student at Tew's Military Academy. He was in later years Chief Justice of the N. C. Supreme court and had a son living in Randolph county at that time.

The Battalions were equipped with clothing, shoes and accountrements as well as the government at that time could do, but were armed with Enfield rifles, which had been changed to percussion from flint and steel, and which were well nigh worthless. Later on better guns, which had been captured in Virginia, were issued to the Juniors.

The Regiment participated first in many skirmishes in and around Weldon-Plymouth, Tarboro and Hamilton, N. C. in the summer of '64. On Dec. 10 they participated in the battle of Belfield, Va. In February of '65 the first Regiment went to Kinston, N. C. and became a part of Gen. Hokes Division and remained so until the end.

In March the Regiment was in the battle of South West Creek, N.C, and on Mar. 18-19-20th took part in what was the last major battle of the war, that of Benton-ville, N.C. where General Joe Johnston with 14,000 men attacked Sherman's army of 70,000 and held them at bay for three days until threatened by encirclement the action was broken off and the final retreat began, Gen. Johnston hoped to join Lee on his westward march but after learning of Lee's surrender at Appromatox, General Johnston surrendered his army in Randolph and Guilford counties, N.C.

Company F of which Pvt. Hick's was a member 5 being one of the few companies to surrender in its own home county, Randolph. The men were mustered out at 6 Bush Hill(now Archdale), Randolph county, N. C. May 2, 1865, each man being paid 1(one) dollar and 25(twent five) cents in silver from money General Johnston seized in Greensboro, N.C. belonging to the Confederate government.\*

#### WILLIAM HICKS, VETERAN, C. S. A.

As a historical venture of our Blackford County, Indiana, Historical Society and because we want all records of the many cemeteries, small or large, recorded, we have copied all the stones to the best of our ability and this record has been microfilmed through the good offices of the Genealogical Society of the Church of Jesus Christ of the Latter Day Saints, Salt Lake City, Utah. Also we have copied death records for our County, 1882 to 1930, and of Hartford City, 1900 to 1907. These, too, have been microfilmed. All the records are bound into books for preservation sake.

The small cemetery at the west edge of Roll, Blackford County, Indiana, had no known war veteran. By comparing names and dates with the card indexed record of Union Veterans at the Indiana State Library, Archive Section, we came up with a zero. Not until the death records were checked with old newspaper files at our Public Library did we find a Veteran of the Civil War buried in the Roll cemetery and this Veteran had never had a marker until now.

William Hicks died Dec. 15, 1925, and a search of the Hartford City, Indiana, newspaper, The Times Gazette, Wednesday, Dec. 16, 1925, revealed this:- "William Hicks dies at Roll. Age 79, died Tuesday about 10:45 P. M. at his home at Roll. Survived by wife and three children, Mrs. Minnie Leonard of Liberty, Indiana; Thomas Hicks of Detroit, Mich.; and Mrs. Kate Carmin of Detroit, Mich. Mrs. Lizzie Hayes, of Knightstown, Indiana, is a sister. He leaves three brothers, one on Grant county, Indiana. A veteran of the Civil War, Confederate forces. Forty years in this county. Employed at one time as janitor of Methodist Episcopal Church at Roll."

The Times Gazette, Saturday, Dec. 19, 1925:- " The funeral of William Hicks, who died at his home at Roll last Tuesday, was held Friday afternoon from the M. E. Church there. Burial was made at Roll.

Deed Book 29, page 500 shows that Nathan M. Robey, and wife, Mary E. Robey, of Blackford County, Indiana, sold to Jane Hicks, of Blackford County, dated March 6, 1912. "Commencing at the center of the road north of the N. W. corner of the Susannah Mills' lot, now owned by J. R. Harrold, thence west 2 rods,  $5\frac{1}{2}$  feet, thence north 17 rods, one foot to the place of beginning, containing  $\frac{1}{2}$  acre, more or less, being a part of the east  $\frac{1}{2}$  of the NE  $\frac{1}{4}$  of Section 9, Township  $2\frac{1}{4}$  North of Range 10 East." By this record we note that William Hicks and wife Jane, were not too well possessed of this world's goods.

A search of marriage records of our Blackford County brought forth some interesting things that prompted futher search. Book H, page 234, Clarence Wilson and Kate Hicks were married March 19, 1908. In the marriage application, Kate Hicks, born June 12, 1890, Blackford County, Indiana, father William Hicks, born Randolph County, North Carolina, and mother, Jane Morris, born Shelby County, Indiana. Marriage Book I, page 92, Thomas Hicks and Minnie P. McConkey, married Feb. 13, 1909. He was born April 3, 1887, son of William Hicks, born N. C., and Jane Morris, born Rush County, Indiana. After a search of Rush County, Indiana, records, we find that William Hicks and Jane Morris, married Dec. 25, 1870. These records established the facts that Mr. Hicks was born in Randolph County, N.C.

The announcement of the death of William Hicks, Dec. 15., 1925, and that he was a Veteran of the Civil War, Confederate States of America, and the fact of his birth as Randolph County, North Carolina, led to futher search.

A Museum and Historical Society directory gave us the address of Mrs. Laura Worth, Randolph County, N. C., as their County Historian. A letter to this lady was in turn placed in the hands of Mr. Alton Culver, Randleman, N. C. who is chairman of Randolph County Confederate Centennial Committee, who listed three William Hicks' who served from that County or neighboring Davidson County. Our National Archives, having custody of Civil War records, was then consulted, and we came up with records for two William Hicks; William J. Hicks' record was eliminated because it stated that he passed away in 1864, leaving only one veteran by that name in Randolph County, N.C. A certified copy of the death record shows that our William Hicks was born Sept. 11, 1846 and died, Dec. 15, 1925, age 79 years, 3 months, 4 days. He was 17 years of age at the time of enlistment, May 30, 1864, Company F, 70th Regiment, North Carolina, Junior Reserves; this regiment was also known as the First Regiment Junior Reserves. The record does not state the duration of service.

As before stated William Hicks married Jane Morris, Dec. 25, 1870, Rush Co., Indiana. A certified copy of her death record gives her full name as Eliza Jane Hicks born Nov. 24, 1850, and died July 19, 1937, age 86 years, 7 months, and 25 days. The local paper, Monday, July 19, 1937, gave a little note of her death at 10 A. M. on that date. She left a son, Thomas, of Detroit, M.ch., and a brother and two sisters. Tuesday, July 20, 1937, "Funeral of Mrs. Jane Hicks, age 86, widow of William Hicks will be held Wednesday afternoon at 2 P.M. with burial in the Roll cemetery. Leaves a son, Tom; Catherine Carmin, a daughter, died eleven years ago. Wm. Hicks, the husband, died twelve years ago. She was born in Rushville, Indiana. Had four grand-children. Member of Roll M. E. Church."

Their little home at Roll, according to the deed records, was purchased by Jane Hicks for \$300.00. After her death, the estate was administered and the home sold for \$50.00, Aug. 4, 1938.

Randolph County, North Carolina, marriage bonds, dated Dec. 8, 1845, show that Fincher Hicks married Jane Robbins and the 1850 Census of that County shows a son, William, age 4, and Fillmore, age 2, along with Toll Robbins, age 18, who probably was a brother of Mrs. Finch Hicks. By 1860 the family had increased to William; Seth; Becky; Eliza; Thomas and John.

Rush County, Indiana, Census 1870, shows William Hicks, age 23; Robert, 20; Rebecca, 19; Mary E., 17; Thomas F.,;h; John A., 11; and Irvin, age 8. No doubt the parents had passed away by 1870 and William Hicks was considered "head of the house," and Rebecca, a sister, "keeping house." William had assumed the important task as head of the house.

Now back to our beloved Blackford County, Indiana; the 1880 census for Washington Township show William Hicks, age 33; Jane, his wife, age 29; Etta, a daughter, age 9; Minnie, a daughter, age 4; and his brothers, Robert, age 31; and Thomas, age 24. It also states that he and the two brothers were born in North Carolina.

Various "Fnumeration of Voters" for some years show that William, Thomas and Robert Hicks have been legal voters of Washington Township, Blackford County, Ind., for years. They also owned property in the same township.

We pause to contemplate the long ago years of the Civil War and we conclude that William Hicks did his duty as he clearly saw it in that era. What would we have done in a like situation? It is well known that these dear people were good Christian folk in our community and they were members of the Roll Methodist Church. He was a humble man and never sought fame or honor.

Let us conclude with Psalm 133, "Behold how good and how plesant it is for brothers to dwell together in unity. It is like the precious cintment upon the head, that ran down upon the beard, even Aaron's beard, that went down to the shirts of his garments. As the dw of Herman, and as the dew that descended upon the mountains of Zion, for there the Lord commanded the blessing, even life evermore." Paul in the Letter to the Ephesians states that we walk worthy of the vocation wherewith ye are called. With all lowiness and mackness, with longsuffering, forbearing one another in love. Endeavoring to keep the unity of the Spirit in the bond of peace." Such was the life and spirit of William Hicks our lonely soldier of the Confederate States of America.

"In order that my children may have the chart of descendants of Edward Beeson more complete and showing their line of descent from him, I wish to add information that I have obtained from various sources, such as Bibles, County Histories. Quaker Records, newspapers, Court Records, and other County Records. I shall proceed from Richard Beeson, son of Samuel and Elizabeth (Brooks) Beeson on said charts, I must state that this chart was compiled by Henry Hart Beeson, now a resident of Dallas, Texas. (Written, June 10, 1955-N. R. H. S. permission to print I give, March 1960.)

Encyclopedia of American Quaker Genealogy, by Hinshaw, Vol. 1, p 770, (Deep River Monthly Meeting), lists:

After many years of searching various county records and after much correspondence, I was very happy to recieve the old family Bible of Richard and Nancy Beason as a gift from Mrs. Clarence Gharst, Somerset, Indiana, who is a cousin to my father, William H. Beeson. That was on Sunday, November 6, 1949. The old Bible was small, and it contained the record:

Richard Beeson, born April 28, 1788
Nancy Cain, born August 12, 1783
"Richard and Nancy were married January 11, 1807."
Children:

Elizabeth, born November 5, 1807
David W., born March 1, 1809
Raburn, born November 19, 1812
Abner Brooks, born March 24, 1817
Mary, born September 25, 1821
Tary, born January 27, 1824

Page 799 of Vol. 1, Quaker Records, by Hinshaw, show that on October 5, 1807 Richard Beeson condemned his marriage out of unity, which may show that his wife, Nancy Cain, was not a Quaker as his people were. From that date on there is no further record of him in the Quaker Church Records.

We next find Richard and Nancy Beeson as being early settlers in Green County, Ohio. The History of Green County, Ohio by Broadstone, Vol. 1, page 313, show that they came to that County in 1808 and bought 50 acres of land at 50¢ per acre. He erected a log cabin and by 1817 was ready to move to the West.

On November 5, 1818, he bought land in what is now Randolph County, Indiana, N. E. 4 of Section 21. I believe this to be in Ward Township near what is called Deerfield. The 1820 Census lists him in Ward Township. He also bought Lot No. 17, Town of Winchester, Indiana, February 11, 1820.

Having disposed of this property, he proceeded to purchase land in Allen Co., Indiana, which he did on March 10, 1825. This is in Wayne Township of that County, as shown by The Land Office Records, Washington, D. C. He died about 1829, as the property was divided among the children and there is no mention of him in the County records except as to the administration of said property.

The old family Bible of Louis Petty, Peru, Indiana, shows that: Abner Beeson married Nancy Caroline Petty, July 3, 1842, Nancy being a daughter of William and Mary(Coggshall) Petty, of North Carolina. Their children were:

William died in the Civil War.
Newell Beeson, married four times. Newell lived in Wabash, Indiana.
Orel Beeson, married John Hettmansperger.
Eliza Helen Beeson, married John Nieswender.

After the death of Richard Beeson at or near Fort Wayne, Indiana, the widow Nancy Cain Beeson, moved to Miami County, Indiana, and bought Town Lot No. 124, in the city of Peru, Indiana, August 18, 1846.

Abner and Nancy Petty Beeson moved to Crawford County, Illinois, previous to 1850, as the census for that year lists the family there and having the following children:

William E. Beeson, age 6, born Indiana Newell Beeson, age 4, born Indiana Eliza H. Beeson, age 2, born Indiana

The 1860 Census for Stiflevill P. O., Crawford County, Illinois lists the youngest child as Orrel, age 6, born in Illinois.

The 1860 Census of Agriculture shows that Abner Beeson owned 80 acres of improved land and 40 acres of unimproved, with the value of \$1500. Implements of \$10. valuation. His livestock as of June 1, 1860, was as follows: horses 2, milk cows 3, swine 10, with total value of \$300.00. Because of hog cholera, the family suffered financial loss, sold their property, and returned to Erie Township, Miami County, Indiana.

Abner and Nancy Beeson recieved a pension for the services of their son, William, who died September 1, 1864, during the Civil War. Abner Beeson died February 2, 1892, and Nancy(Petty) Beeson, died February 9, 1889, Wasbash County, Indiana. The Beeson's, Cain's and Petty's came from North Carolina. (Ed. Randolph County, N.C.)

Newell Beeson, son of Abner and Nancy Beeson, married Mary Launder, Wabash, Indiana, June 18, 1871, having two children, William H. Beeson and Abner Beeson. Abner went West and was never heard of again except after his death in the State of Washington. I possess his watch, as it was returned to my father, William H. Beeson Mary Beeson filed suit for divorce, Feb. 14, 1877, which states: "--as the fruits of said marriage, to wit.: Willie, aged 4 years and Abner, aged 14 months..." Mary Launder Beeson perhaps died about 1878, as I could not find the final papers in this legal action. Newell Beeson, later married Amananda Fagu, Emma Hooven, and then Norella Hayes, at Peru, Indiana. Newell Beeson died at Peru, Indiana, Sept.8,1909.

William Henry Beeson, born Jan. 19,1873. Jennie Jenks, born July 15, 1873, daughter of Samuel Jenks Jr., and Nancy Jane (Sherwood) Jenks. Married June 20, 1895, at Wabash, Indiana, by Rev. Charles Little. Jennie (Jenks) Beeson died at Hartford City, Indiana, Jan. 29, 1912. (Note, Mr. Beeson; "Dad died Aug. 25, 1957 at Portsmouth, Va., buried at Wabash, Ind., Falls Creek Cementery.)

There were three other children who died in infancy, namely: Ned, Mildred, and Harold Morris Beeson. We moved to Hartford City, Indiana, about 1910 or 1911, as my father had to work in the paper mills.

#### LAND LAW

"The basic land law of 1777 required each county court to appoint entry taker and surveyor; the claimant to land had to make a written claim to the entry taker, stating the location and approximate boundries of the land, etc. The claimant had to pay the entry taker 2 lbs & 10 shillings per 100 acres for amounts not in excess of 640 acres for him-self and additional 100 acres for his wife and each child, and 5 lbs for each 100 acres above 640. The surveyor's fee was 16 shillings for each 100 acres.

In 1790 the sale price of land was fixed at 30 shillings per 100 acres; in 1794 it was increased to 50 shillings, that is from  $7\frac{1}{2}\phi$  to  $12\frac{1}{2}\phi$  per acre."

#### QUAKER GIRL WRITES HOME TO RANDOLPH COUNTY FROM INDIANA

ONE HUNDRED, THIRTEIN YEARS AGO
(Courtsey: Tommy Julian)

(In working with some Julian material for future issues of the Quarterly, I found several very old letters with the material and hope to print others as we work on the material. Feantiful hand riting and croied as prote.)

Ind. Rush County

November 30th 1856

Dear Uncle

Hoping thee has not so far forgotten me but thee will be willing to recieve a few lines from me though many long years has elapsed since I saw thee yet thee has often very often been remembered by me in tender feelings of affection I indeed have had many ups and downs since I saw thee many sore trials to pass through some of which thee has heard if I should live I may have many more perhaps in various parts of the wourld(sic) I & my three youngest children are staying at Aunt Sarah Commons our oldest son Hilton is teaching school in Hendrix County Indiana our second son Samuel is going to school at Friends Boarding School Richmond Ind. our 3d son Tobia Julian started with his Father yesterday to go to Iowa & perhaps Nibraska & Kansas They(the) twins are here going to school there is a good school house here at the end of the lane a good Teacher by the name of Benjaman Morgan is now teaching there has a good school. I suspose that thee had heard that we were at Friend Mission. Kansas Toretory we stayed there more then 12 months in the midst of many cares trials & dificutys On the 20th of 8th mo. last 18 men came to the Mission armed they took all they(the) horses but one that had his ankle cut with a plow so he could only walk on 3 legs They (the) men were Ruffins of the roughest kind they took two horses of ours one mule of Miltons 2 horses belonging to the Mission and one that belonged to a man in Indiana his name is Woodard They Ruffins said they would return in less then a week burn the Mission kill all they men take they women to there camp & go(?') This alarmed the teacher & her Sister who was there they knew such things had been done by they Ruffins they had parents living in Indiana & good home to go too they were anxious to return but I was sick with conjestive chills at the time I told them as soon as I could travil we would start for Indiana as soon as I got so I could setup a little they comenced packing up some of our clothing in trunks so on the 23rd we started for Indiana Morgan County where we arrived in 4 days I met with many of our old friends who seemed truly glad that we had made our escape from such scenes of trouble we have had many strong solildations to return to the Mission but my health has failed that is to great an concern for a weakly person Kansas is a good country but I would rather not take my family there any more until thare is permnant peace established there

We attended the Yearly Meeting stayed at Aunt Elizabeth Coxes severel nights they were all well and doing well they had more then 20 boarders all the time at three & half dollars a week they girls Jane & Evealine are haveing a brick house built they say it will cost them \$1000 we saw many of our relatives there Uncle Jacobs Tobias unc.(uncle?) Isaacs Jacob & Isaac Aunt Sally came on first day said she came to git us to stay with her this winter as she would have to stay alone if we did not her children has all left her she has one son living & 3 daughters her son Jesse lives 1 mile from here is doing well his farm is well improved he has been offered \$50. per acre for it but would not take it Eleanor her oldest daughter married Joseph Overman lives 3 miles from here has a good farm near Carthage Lydia is living in Knightstown 3 miles from here she is doing well she has her 3d husband his name is Gordan Hu(n?)litt Ellina is maraid to Allen Hatfield lives 10

miles from here in a town by the name of Cleveland her husband is a merchant & has a part in the depo there they are doing well. They 3 youngest sons have all deceased John left a widow & 3 children Isaac was not marriade Lewis died when an infant

Aunt Sally says she wants thee to write to her soon and tell her all about they own family and others of old acquaintance & relations she also wants John to write to her we learn from a letter from brother Hoingil (?'ink blot) that Patience Allred has deceased Aunt Sally wants thee to write to her what her disease was if she was sick long --(?) & what her age Aunt --lly(Sally ?) has had 21 grand child-ren but 14 now living She got a letter from Uncle Jacob wrote the 16th of this mo, they were about as well as common his son Isaac moved to Minnesota last spring he has moved back to Indiana is now on visit to see his relations in Wayne Henry & Rush we are looking for them here in a few days Please show this to all our relations I want James and Martha Hinshaw to write to us Direct your metter To Knightstown Henry County Ind. I expect if I live to stay here til next spring where our address will be then I cannot tell Dear Uncle & Aunt my mind often recurs back to those happy days when I used to hurry through my work at my Fathers house to git a little time to go to your house & be with they girls but the past is gone forever it can only be lived over in our memory. Aunt Sally intends walking to Knightstown tomarrow to see Lydia & put this in the office I filled my sheet so Farewell this in love from your neice

"A DELIGHTFUL DAY AT UNCLE TOBIAS"
(From Tommy Julian Files)

'On the 20th day of August 1902, quite a number of relatives and friends gathered at Mr. Tobias Julian's to celebrate his 77th birthday. Mr. Julian lives near Millsboro, N. C. The arrival of the party was quite a surprise to him, as he knew nothing of the preparation for the dinner. By 12 o'clock, 99 people had arrived, each with a basketful of good things to eat. A table was made across the yard long enough for all to stand around. After the children were well helped the older ones were served. Children say they always have to wait for the "big folks", but it did not happen to be so at "Uncle Tobias." In the afternoon the dinner party, with Mr. and Mrs. Julian, went to Bethany church where they heard an excellant sermon preached by the Rev. C. T. Whitaker.

Mr. Julian's ancestor's were French. His great-great-grandfather, Rene St. de Julian served as an army officer during the reign of King William. He was granted a tract of land in the Miss. Valley, and near the close of the 16th century he deserted the Catholic church, joined the Protestants and came to America. His ship stopped at Bermuda Islands were he was married to Miss Mary Bullock, and English lady of eighteen summers. He was then 40 years old. They first landed on the eastern coast of N. C. After living there a few years they moved to Va. and then to Maryland. Their oldest son, Isaac married Barbara White of Winchester, Va. and came to N. C. and settled on the plantation where Tobias Julian now lives. When Isaac Julian passed away, the home was left to Isaac Julian, who married Sarah Long and was living there during the Rev. war. It is said that Gen. Green's army camped near the house. An old mulberry tree marks the camping ground. Isaac's son Bohan, father of Tobias, was next to have possession of the old home place. His wife was Jane White before her marriage. Tobias Julian has twice been married. In 1847 he married Elizabeth Osborne. In 1854 he married Phoebe Jester, his present wife. He has 7 children living, 12 grandchildren and 8 great-grandchildren. Mr. Julian says he was never intoxicated and never swore an oath! (Ed. no note where this came from)
