

### DATA OF MENDENHALL GENEALOGY

William F. Mendenhall

Ed. note: We are printing data sent to us, concerning Mendenhalls that may help others with the family. Mr. Mendenhall, a member of our Society.

In order to keep the records straight on the Mendenhall family of Piedment, North Carolina, including the Counties of Alamance, Guilford, Randolph, Orange, Chatam & Forsyth we must go back to the beginning of the great Quaker movement into America from England.

Benjamin Mendenhall, who married Ann Pennell, and his brother John Mendenhall, who married Elizabeth Maris, were the progenitors of the Mendenhall families in America. However, they had two sisters; Margery Mendenhall, who married Thomas Martin, and Mary Mendenhall, who married Nathaniel Newlin, which connects the Mendenhall family with a famous Quaker family in North Carolina--the Newlins.

This family of Mendenhalls were the children of Thomas and Joan (Strode) Mildenhall (the original spelling of the name), all born in Mildenhall, Wiltshire County, England. The children immigrated to Concord Meeting (then in Chester County) now Delaware County, Pennsylvania in the year 1681.

Another confusing thing about the Mendenhalls that settled in Guilford County is the family kin. John Mendenhall and Elizabeth (Maris) Mendenhall had two sons--John, who married Susannah Pierson, and his brother Aaron, who married Rose Pierson. They were daughters of Thomas and Rose '(Dixon) Pierson. Rose (Dixon)Pierson was the daughter of Henry and Rose Dixon who immigrated to Pennsylvania from Ireland about the same time as the Mendenhalls. Henry and Rose Dixon had three children -- William married (2nd) Ann Gregg, Dinah married Michael Harlau (of the famous Harlan family), Rose married Thomas Pierson. The noted Dixon family of North Carolina comes down from this family of Dixons.

The first Mendenhall to settle in Guilford County was James Mendenhall, the builder of Jamestown. He came straight from Chester County, Pennsylvania before 1740. He was the son of Aaron Mendenhall and Rose (Pierson) Mendenhall. Later Mordecai and his brother Stechen Mendenhall came to New Garden. Mordecai and Stephen and James Mendenhall were double first cousins. James married first Martha Griffith, and second, Hannah Thomas. Mordecai Mendenhall married Charity Beeson, Stephen Mendenhall married Rose -----. Benjamin Mendenhall had some kin to move into western North Carolina and South Carolina. One of his despendents. Ann Mendenhall, married John Bartram, the noted Botanist.

I did not mean to get into so much family background. However, the families are so interconnected by marriage, it gives a clearer picture of the Quaker Mandenhall family. In some cases the Mendenhalls are Mendenhalls more than once. (MENDENHALL GENEALOGY cont'd)

James Mendenhall's family were in the tanning business. They manufactured shoes and harnesses. They were also builders--and good ones. A few buildings in Jamestown will bear that fact out to this day.

Mordecai Mendenhall was a farmer and dealt in the lumber business and was also a builder. The fact is that the Mendenhalls of that line are still in the lumber business.

The greatest calling of the Mendenhalls of both lines are the church, government, legal, business, medical and education. In the last named, education, they have excelled. I will not separate the families in the order they are mentioned in the educational field.

Nereus Mendenhall was one of the founders of Guilford College. Mary (Mendenhall) Hobbs was a long time teacher. Mary E. Mendenhall and Gertrude W. Mendenhall were also teachers. Gertrude was later to head the Math Department of the W. C. U. N. C. at Greensboro. George Mendenhall founded a Law School at Jamestown, North Carolina. Joseph Mendenhall, Benjamin Mendenhall, and Ruddock Mendenhall (sometimes called Reddick which is incorrect). Reddic is another, although he was a school teacher also. These Mendenhalls were instrumental in founding Trinity College at Trinity, Randolph County, now Duke University at Durham, North Carolina.

Sarah (Mendenhall) Brown served on the School Board at Greensboro as did Jabez Mendenhall, a former Mayor of Greensboro. Evelyn (Mendenhall) Thompson was Chairman of the School Board at High Point for over twenty years. Eliku Mendenhall, Nereus Mendenhall and Edward E. Mendenhall, Jr., served on the Board of Trustees of Guilford College. Marjorie (Mendenhall) Applewhite taught at Guilford College and the University of North Carolina. Marion (Mendenhall) Lee was also a teacher at the University of Florida.

Alpheus L. Mendenhall was also prominent in the educational movements after the Civil War. He was a leader in the establishment of the Normal College at Greensboro. He also taught school in Wilson, Goldsboro and Centre township.

Grimsley A. Hobbs, President of Guilford College is the grandson of Lewis Lyndon Hobbs and Mary (Mendenhall) Hobbs; Dr. Hobbs was the first president of Guilford College.

Some Mendenhalls that were Central North Carolina matives made their mark in the educational field in other states. To name a few: Birkenshaw Mendenhall, head of Department of Education at Ohio State University; Nereus Mendenhall became County Superintendent of the Public Schools of Mead County, Kansas; and Mary Mendenhall was Dean of Women at San Diego (Caligornia) State College. In most cases, each had a Doctors Degree, that is, most of the Mendenhalls mentioned throughout this outline.

Marmaduke Mendenhall was an educator in Charleston, South Carolina, as well as being a physician. Mordecai Mendenhall, Jr., was a physician and his son, Ira was also a physician of some note.

In the business field, some of the Mendenhalls were of some prominence. Ottis E. Mendenhall was a Real Estate Broker in High Point. Edward E. Mendenhall, Jr., was President of the National Association of Real Estate Bcards as well as being in the Real Estate business and banking business in High Point. William D. Mendenhall is the head of a lumber business in Greensboro following in the footsteps of a long line of Mendenhalls in the lumber business.

Fremont Mendenhallwas a banker and mill operator in Thomasville. Emory M. Mendenhall left North Carolina to found the largest dry cleaning plant in Dayton, Ohio. James Edward Mendenhall and his brother Robert established a large printing business in Indianapolis, Indiana. William W. Mendenhall, son of Stephen, laid out the town of Jamestown, Ohio. Ence Thomas Mendenhall, who came to California from Springfield near High Point in 1847, established the E. T. Mendenhall Ranch at the foot of Palomar Mountain in San Diego, California. It was the largest cattle ranch in Southern California at one time. He was called the "Cattle Baron of Palomar". He was a Quaker all his life, He was instrumental in founding the Palomar Meeting of the Friends Church.

In the political field, the Mendenhalls have held some high offices. Jabez Mendenhall was a Member of Congress, Mayor of Greensboro, and a member of the N. C. State Legislature, as was Ottis E. MEndenhall and George Mendenhall. Edward Jay Mendenhall was a long time member of the City Council of Greensboro.

Two natives of Greensboro served in political capacities in California: John Mendenhall was a California Assemblyman from Colusa County; William F. Mendenhall, Mayor of the City of Signal Hill (Oil capital of California) and a veteran member of the City Council. William F. also served on the Los Angeles County Sanitation Districts and the Water Board and numerous other Los Angeles County Commissions.

# THE STATE RECORDS OF NORTH CAROLINA

## Vol. XXII Miscellaneous By Clark

The volumes of the Colonial and State Records contain more interesting information than the twenty-second. It contains the Journals of the Constitutional Conventions of 1788 and 1789.

Some interesting date has been collected with regard to the several "Alarms" made on the coast by Spanish invasions. In 1741 some Spanish privateers took possession of Ocracoke Inlet, seized the Vessels arriving, landed and destroyed the Cattle of the inhabitants and devastated the country. Vessels of provisions were sent for relief of the sufferers, at a cost of the province of more than ten thousand pounds.

In like manner, there were two alarms on the Cape Fear the following year. Early September 1748 Spanish Cruisers made an attack on Brunswick.

The wills of Governor Gabriel Johnston, Matthre Rowan and Arthur Dobbs are listed.

This volume is rich in Revolutionary matter. The narrative of Col. David Fanning is carried in the volume written several years after the war. It is wise to have corroborate testimony in regard to Fanning's statement.

Page 314 is the return of Col. Rutherford's Regiment of the Bladen Militia for the year 1754 with the rosters of many counties given. There is a roll of Revolutionary pensioners, declarations by different applicants when seeking pensions. There is much matter, not carried before in other volumes of Tryon's expedition against the Regulators.

The constitution of the State of Franklin, correspondence relating to the establishment and passing away of that common-wealth within the limits of N. C. also is of much interest.

This volume was collected and edited by Walter Clark, Chief Justice of the Supreme Court of N.C. 1907.

Two of the declarations follow that shed some information of our area.

### John Denny

He was in February, 1833m residing in Guilford County, N. C. aged 75 years, and states that about the middle of December, 1779 or 180 he was deafted into the Company of Capt. Frost & Lt. Hancook, marched from Rockingham, N. C. directly to Charleston, S. C., where they went into winter quarters and remained there until April 4th, following when he received his discharge from his Captain and returned home. The next Fall he volunteered under Capt. Andrews Wilson, in which Company he served sometimes, and sometimes in that of Capt. O'Neal "And was used to counteract the scouting parties sent out by the British while on Dan River, Va., and in Rockingham and Guilford Counties," but does not recollect how long he was thus engaged, probably, however he thinks, at least two months. In the latter part of June, 1781, he voluntcered and marched under Capt. Robert Bell, with other Companies from the neighboring Counties, to join G eneral Greene, at Camden, then over the Wateree to Eutaw Springs and at that place he was engaged in the battle of September 8th, 1781, which commenced early in the morning and very quickly. became general. After the battle he was marched with about 300 prisoners of the enemy to Rowan County, N. C. During the battle his Company was placed under the command of a French Colonel, he believed to be named Malmedy. He was discharged after 3 months service. His rank during his term of duty was as a private.

He was born in Ireland and brought when a child, by his parents to America and he settled in Chested County, Penn,, where he lived until 17%2 then with his parents moved to N. C. and settled in Guilford County, where he has since been living. In the reorganization of the Continental Army in 1778 and 9 and a more general one in the Fall of 1780 and early in 1781, Regiments and Companies consolidated which changed the officers in command, and some became supernumaries.

# John Montgomery

He stated in August, 1831, that he was residing in Guilford Co., N. C. and he was born in Lancaster Co., Penn. In 1767 he moved with his father to Guilford Co., N. C. where since living. He stated in August, 1832, that he was 69 years old.

In the latter part of 1780 he volunteered with Capt. Bell who marched up the Yadkin River after a band of Tories, but as they had been routed by

the Militia from Surry County, he returned home, -- absent more than one week. Shortly after, he volunteered under Capt. McReak in Maj. Blair's command, going up Abbott's Creek, in Stokes Co., after Tories who were dispersed. Absent two weeks in December, 1780. Immediately following, he marched as a Volunteer under Capt. Forbis, Cols. Paisly and Martin, to join General Greene (who was retreating from before the British), in Caswell Co.,, thence with him to Halifax, C. H., Va, where information was received of the ravages of the Tories in the neighborhood of Capt. Forbis, who obtained permission to return home with his Company (after six weeks absence). When they reached Guilford, the Tories had fled the County, and Capt. Forbis resilved to join the army again, but before leaving Guilford, prisoners were sent to him to guard, of which guard Montgomery was one and he was on that duty when the battle was fought at Guilford (March 15th, 1781). After the battle he was released from the care of prisoners to go to Randolph County against some Tories gathered in the High Hills, called the Caraway Mountains. (About 10 weeks). The September following he volunteered with Capt. Stewart who marched in the command of Col. Martin and General Rutherford down the country to near Wilmington, and was engaged to near Christmas ckecking the ravages of British and Tories, who often turned out in parties to plunder and destroy plantations. About three months.

# An Account of Persons Who Took The State Oath 1778

And that all persons being quakers, Moravians, Menomists & dunkards & under the curcumstances above mentioned in Law, shall make the following affirmation or depart the State.

I, A. B., do solemnly and sincerely declare and affirm that I will bear true Fidelity to the independent State of North Carolina and to the Powers & authorities which are or may be established for the good governments thereof and I do renounce any Fidelity to the present King of Great Britain, his Heirs and Successors, and that I will disclose and make known to the Governor, some member of the Council of State, Judge of the Superior Courts or Justice of the peace, all Treasons, Conspiracies or attempts Committed or intended against the same which shall come to my knowledge.

# DR. C. E. WILKERSON IS CLAIMED BY DEATH

# Greensboro Physician Passes At His Summer Residence Near Randleman

#### Funeral to be Sunday

Dr. C. E. Wilkerson, prominent local physician and well known throughout Guilford and Randolph counties, died yesterday morning at 4 o'clock at his summer residence on the High Point-Asheboro road near Randleman. He had been ill since Sunday, May 20, when he was taken sick while attending services at Bethany Methodist church. He was removed to his summer home where he seemed to be improving until the past week, when his condition grew worse.

The funeral will be held at 4 o'clock Sunday afternoon at Mount Lebanon Mathodist Protestant Church at Randleman. Rev. R. Murphy Williams, pastor of the Presbyterian Church of the Covenant, and Rev. W. A. Way, pastor of the Pilgrim Holiness Church, Edgeville, will officiate. Interment will be in the church cemetery.

Active pallbearers will be C. E. Everhart, W. F. Matthews, David Ferree and A. B. Beasley, of Randleman Masonic Lodge No. 209, and J. K. Gilback, W. J. Hall, T. A. Swain and F. W. Russell, of Randleman Council No. 31, Junior Order of United American Mechanics. Dr. Wilkerson was prominently connected with both those orders.

Honorary pallbearers will be Dr. J. R. Johnson, of Ramseur; Dr. J. T. Barnes, Dr. R. P. Sykes and Dr. W. L.Lambert, of Asheboro; Dr. T. E. Helms and Dr. Kistler of Randleman; Dr. R. A. Schoonover, Dr. Wesley Taylor, Dr. H. H. Ogburn, Dr. H. Lee Wyatt, Dr. A. F. Fortune, Dr. J. G. Thomas, Dr. J. N. Taylor, Dr. A. D. Ownbey, Dr. J. H. Boylels, Dr. C. W. Moseley, Dr. S. R. Cozart and Dr. Samuel F. Ravenel.

Dr. Wilkerson had devoted his medical practice to this section of the state since 1908, when he first settled at Worthville, in Randolph county, where he opened a small hospital. He established a residence in Greensboro in 1926, his home being at 1703 Madison Avenue, and became affiliated with Clinic hospital. He was 65 years old.

Surviving him are his wife, and one daughter, Miss Treva Wilkerson, of Randleman; one son, Philip Wilkerson, of Randleman; one sister, Mrs. J. P. Brumley, of Adamsville, Tenn.; and four brothers, Walter and J. D. Wilkerson, of Selmer, Tenn.; and R. N. and J. R. Wilkerson, of Humboldt, Tenn.

The deceased was a native of Henderson, Tenn., After conpleting his early edication in the public schools, he took up his preliminary medical ptradies at Nashville university, Nashville, Tenn. His postgraduate work in medicine was done at New York university and the Lying In hospital in New York city. He served his interneship at Columbia hospital in New York city and at St. Leo's hospital, Greensboro.

After going to Worthville, where he remained for three years, Dr. Wilkerson moved to Randleman and operated a small hospital there; but in 1915 he assumed the work of medical missionary for the United Presbyterian church and went to Africa for two years, returning because of ill health. After coming to Greensboro in 1926 he carried on an extensive practice that gave him a commendable record in medical circles of the state. At the

time of death he was a member of the American Medical association, the North Carolina Medical Society, and the Guilford and Randolph county medical societies. In addition to his connection with Clinic hospital he was also a member of the staffs of St. Leo's and Wesley Long hospitals.

Dr. Wilkerson was a member of the Presbyterian Church of the Covenant and had taken part in many of its activities. In addition, he was affiliated with the Randleman lodge No. 209, A. F. and A. M., and the Randleman lodge No. 31, Jr. O. U. A. M.

# Ref.: Colonial Records N. C. Vol. IX 1771 - 1775 - Saunders

September 1770, on the 24th and 25th at the Superior Court of Justice in Hillsborough (Orange Co., N. C.) a mock had been made of the court and runblings were becoming louded before the Revolutionary War broke out. Many were being outlawed for their actions against the mother country.

August 30, 1771 Josiah Martin, Esq. Governor was at the Council Chamber in the Palace at New Bern and among other work (proclamations, atc.) he received the following petitions. These men were all from Randolph County many, possibly all, active in the Revolutionary War.

Jeremiah York became a Loyalist, John McGee, Methodist minister, Shubah Stearnes organized the Sandy Creek Baptist Church. These are a few of their friends and neighbors mentioned here.

### ORANGE AND GUILFORD COUNTYS NORTH CAROLINA

August 25th 1771

States and the states To all persons whom this may concern Know ye, that whereas Thomas Welborn has lived in the neighborhood of Sandy Creek hear hand about fifteen years in the Countys and province aforscaid it tis requested of his friends and Acquaintance, A Letter of his Recommendation, which we the subscribers hereof, Do hereby Certify, the above sd Thomas Welborn to be, A man of Justice and/Honest Integrity in his Dealing and Conversation neither Known, nor suspected to be Guilty of Fraudulent Practices, But Contrary wise, Upright in his Generation, and A true Loyal Tenant to his Majesty, Excepting the Late Insurrection and Rebellion, as did arise in the Countys aforesaid, & Given Under our hands the Day and Year first above written.

## "Mrs. Andrews Paid Honor On Birthday" By Mary Katherine Stork

Mt. Gilead's oldest citizen, Mrs. Ellen Andrews, reached her 100th birthday Saturday, and was feted with a centennial dinner Sunday at the home of her grand-daughter, Mrs. C. M. Capel, where 145 people were present. Gracing the center of the honoree's table was a three tiered cake bearing the inscription "100". Mrs. L. P. Byrd presided over the register at which 215 registered, from several eastern states.

Mrs. Andrews was born near Oak Grove church in Randolph county, November 12, 1832, the daughter of Emsley Lassiter and Sarah Ivey Nance. She was the eldest of five children. Her mother died when she was 10 years of age. Her father was a cripple, in early life came to depend upon her for help.

Mrs. Andrews is the widow of Eli Franklin Andrews, mother of two girls who are both deceased. She has nine grandchildren, Frank and Fred Bruton, Mrs. L. A. Kelly, Mrs. C. M. Capel, Mesdames Macy Haywood, Franklin Haywood, Loy Harris, Charlie Greene and Joe Brookshire. There are 33 great-grandshildren, and two great-great-grandchildren.

When the civil war began, theirs was an unbroken, happy home. Two brothers enlisted in the war, Benson, the elder, volunteered and was in the army two years. He was wounded at the battle of Gettysburg and taken a prisoner to Elmira, N. Y., there to remain until after the surrender. Johnathan died at Roanoke, Va., and his body was brought home and buried by the grave of his mother at Oak Grove church. Her father died in January, 1863. Her only sister dying during the war, she and her youngest brother, Thomas, were left.

April 9, 1865, she was married to Eli Franklin Andrews, of Montgomery county. He was a soldier in the civil war and was in training in a camp near Wilmington, but was petitioned home to care for his widowed, aged mother, after his younger trother volunteered and left home. He was then made a home guard.

Mrs. Andrews says "I have lived through three wars, the civil, Spanish American, and the world war, and therefore, I am for peace."

Mr. and Mrs. Andrews were the parents of two daughters, Sallie A., who became the wife of R. A. Bruton, of Mt. Gilead, and Mary Florence, who married C. E. Brookshire of Pekin. Mr. Andrews died February 25, 1891, at the age of 58 years, and was buried in Sharon cemetery. Mrs. Andrews then lived with her daughters, and now with her granddaughter, Mrs. C. M. Capel, who is her nearest relative. She still visits the other grandchildren.

Mrs. Andrews went to a Quaker school, Old Trinity college, and New Hope academy. Later she taught at Salem church school and New Hope. "I liked to stay at Trinity, but I liked best to stay at New Hope. Colonel Steed was a great director at New Hope."

"I joined the church in my 15th year, I wasn't quite 15. Preacher Alsa Tucker from Greensboro held the meeting at Oak Grove church." Mrs. Andrews has always been a faithful member to the church, never knowing what it was not to attend, and she fully believed in Oak Grove. While relating these things we asked her how to spell the preacher's first name and she said, "Alsa, I think, yes, that's the way, Alsa."

She was a real scholar, and has often spelled for her grandchildren and great-grandchildren. "There was a Quaker church near by, but my parents belonged to Oak Grove. The preacher, Mr. Tucker, made us a mighty good preacher, he was kind, and gave to the poor, he had money of his own, and he had lots of slaves. I never heard of anyone else by his first name. Some people claimed they named their children for him but they didn't spell it that way. During the meeting the preacher would get to shouting and he would go all over the ohurch shaking hands with the members. One night he got so happy he jumped over the pulpit, and he was a cripple, he didn't have but one foot."

"People try now to see how quick they can get home after church, but we used to go around and shake hands with all our neighbors and talk for a long time. The colored folks went to our church too and were members there because they didn't have a church. Some of them sat up in the balcony, and others sat at the back of the church, behind the white people. We always had prayer meeting on Wednesday or Sunday night and if we couldn't have it at church, we had it at some of our houses."

After her marriage she transferred her membership to the Zion, and later to the Methodist Episcopal church, south, at Mt. Gilead, where she is now a loyal and devoted member.

Her father was a tailor. He also had several acres of land in a mulberry farm raising caterpillars. "I don't remember how many acres there were but I remember I got mighty tired carrying worms. We spun thread from the cocoons for all the sewing on silk material. We would get several cocoons together and spin the thread together, if we wanted it coarse we would add more to it and if we wanted it finer we would take some out."

She tells of the hardships of the civil war. "You young folks don't know a thing, if you had lived in a time like we lived in you would have something to write. We hid our silver under the pig pen, and tied the horses in the woods. We would take them as far back in the woods as we could remember to go back and find them. We had to guard everything, too. I wasn't very old but I was old enough to life and push things and hide. The Yankees would go in your smokehouse and get your meat, and if they couldn't carry all your wheat off they would pour it on the ground. What they didn't want to destroy they carried it off with them. They always had several horses to carry the stuff, and sometimes they would lead them instead of riding.

"We used to think the Yankees were the meanest folks in the world. They used to do everything they should not do. I had a watch and chain and so did sister. They would watch you when you didn't know they were watching. You just couldn't keep jeweley, we liked it so much, but they liked it too, and they would get it sometimes to take back to their wives or sweethearts. They would hide it until they got ready to go home or they would trade it off. Some ladies had gold chains, watches, and keys, especially the teachers, they had them.

"The Yankees would bribe you and they would kill you if you didn't do what they said. We made clothes for the boys in the war. The boys didn't do any work. You couldn't depend on your brothers except to fight for you and that was all.

"After the Yankees stole the horses we couldn't drive our carriage, we had to walk. Before then if we want anywhere it was just to hitch up and go. Sometimes we had two horses to a carriage but more often we had four. Usually four grown people rode in a carriage and if we had any children we had them in our laps. Grandma and grandpa saw a hard time; if we were obliged to go we had to leave the children with them so the Yankees wouldn't kill them."

"When I was just a small child after supper we used to have to pick one shoe full of seed out of cotton before we could go to bed. That was our job, (CENTENARIAN RECALLS HISTORICAL EVENTS cont'd)

to pick your shoe full of seed. We made tallow candles. Saved the tallow from the cattle when we killed them and we were very particular with it. Pappy made us candle holders, and the neighbors used to borrow them, instead of making them some. We spun the thread, and wove wicks for the candles. We poured the warm tallow in and put it out to cool. During the war we used to spin and weave, I sat up many nights all night long." When she goes visiting now she often saya: "I better take my glasses along, they might have something in the loom they would want me to see."

She has never been inside, nor seen inside of a hospital. The only serious illness she ever had was typhoid fever. Her health is better than it has been in four or fibe years. She is very happy, and said to her granddaughter the other day: "Don't me and you have the best time?" She is hard of hearing, but she has wonderful digestion. She can eat anything day or night. Sometimes when she lies in bed at night and sees the car lights coming up the street she says to her granddaughter: "Let's you and I go up town and see what the attraction is. Just look at the buggies coming to town."

The last subject she discussed was the 'freshet'. She was married and living near Little River. "This was a serious affair, it destroyed property; water was over the low grounds and they couldn't grind in the mill. They had to wait until the water went down, and it went down so slowly. Nearly all of the cattle near the river were destroyed. We had counted on our pigs. When they were found lots of them were lodged up in the trees. Some were crippled and some could walk a little when they got down. It washed snakes and frogs up in our house. You could hardly get about in the house. Sometimes we had to stay in the big high room (meaning the upstairs)."

### A TRIBUTE TO WILLIAM H. NANCE

South Fulton Recorder, Georgia Wednesday, Oct. 9, 1963

William H. Nance was a remarkable man with a remarkable background. His father, Henry Hancem was a farmer and millright. There are, still standing, mills and water wheels of his construction. He fought during all four years of the Civil War, with his wife Mary bearing the home burden. So William, due to the hardships of reconstruction, came up the hard way.

He was born in Randolph County, N. C. in 1864. Because he was needed to help support the family, his formal education was forfeited, which made him an ardent student, between times and thus he received his education. In Randolph county there were no Negroes and not many of the people believed in slavery. He married Eliza Jane Walls and in 1902 they moved to Davidson county, which became his permanent home.

For 25 years he worked in the furniture industry, and for about 25 years he was a Davidson County Magistrate thus acquiring the name of Squire. During this time he married 180 couples. There are many grandparents today who look back to their marriage by Squire Nance.

He lived through part of the Civil War, the Mexican War, the Spanish American War and two world wars. He was the father of five children, three of whom are still living -- Coy and Della of Lexington, N. C. and B. C. Nance of the Cottage Grove Motel in Union City. William Nance had been a member of the (A TRIBUTE TO WILLIAM H. NANCE cont'd)

Second Reform Church of Lexington for 50 years. This church is now known as the United Church of Christ. His wife, Eliza Jane, died in 1935. He later married Lila Walls, a widow with three sons, Cleveland, Henry and Tom, all of whom live in Lexington; Tom is a Baptist preacher. The 2nd wife died in 1960.

William Nance often spent months in Georgia with the B. C. Nance family, and was then counted as a Georgia citizen.

The last time I saw William Nance, I sat with him and his daughter-in-law in the cozy little motel living room while we talked and enjoyed coffee and donuts. He was an interesting and intelligent conversationalist.

Mr. Nance had a stroke at a nursing home in Durham, N. C., and was taken to the John Umstead Hospital where he died two weeks later on September 13, 1963. The funeral was held in the United Church of Christ in Lexington, conducted by Rev. A. Odell Leonard pastor for 40 years, assisted by his son, also a pastor. Burial was in the Lexington City Cemetery.

Eight of Mr. Nance's great-grandebildren served as pall bearers. He had 30 grandchildren, 68 great-grandchildren and 23 great, great-grandchildren.

He was looking forward to May 1964 when he would have celebrated his 100th birthday. But he will spend it in a better land.

Mr. Nance was a zealous Bible reader, and his consistent, busy life has been a blessing to many through the years. His memory will live on,

- Revolutionary War Veteran Buried Here -

BOYS CLUB TIDIES UP FAMILY CEMETERY by L. S. Feid

Year after year, first by train and then by auto, Mrs. Ida Prichett came all the way from her home in Nebraska to the Bethalto area to see that the family cemetery was maintained in proper order.

So the private Prewitt Cemetery - Mrs. Pritchett was a Prewitt - was always tidy as could be.

Her only son, who died in infancy, is buried there.

When Mrs. Pritchett made her annual trip by car, she hired a Nebraska youth to drive; under her supervision he would cut the cemetery grass, remove the weeds, see brambles made no headway.

The Prewitt Cemetery, earlier members of the family spelled their names Preuitt, is located about 100 feet back from what oldtimers called "the road by the Preuitt place," the road running from Rte. 140, at a point near Zion Lutheran Church, to Rte. 159.

As a girl, Mrs. Pritchett lived on the sweeping Preuitt Farm acres - of which the cemetery was a part - for in pioneer days some families had their own cemeteries on their property.

The Prewitt burial ground,  $46 \times 56$  feet, and enclosed by a concrete wall with an iron gate, was established a long time back - 128 years ago.

For in 1844 Martin Preuitt, who brought his family from North Carolina to Illinois in 1806, is buried there, having died at 92.

Historically speaking, the two most important members of the Pruitt family interred in the plot are Martin, a Revolutionary War soldier, and his son Solomon, an important figure in Illinois Ranger and militia circles.

In Mrs. Pritchett, the deceased Preuitts had a loyal descendant.

But the time came when she did not appear on her annual pilgrimage for the upkeep of the family burial ground - she too had died.

And nobody came forward to take up the task she had so faithfully carried out.

Disinterest in the cemetery continued year after year.

The plot's grass grew wild and high; the weeds flourished unsnipped; brambles began to creep in; even treelets took root.

Also, the marker over Martin Preuitt's grave became oblitherated with wild growth - he became a Revolutionary War veteran unsung.

But finally someone - not a Prewitt - who prefers to remain anonymous, became disturbed on discovering the historic cemetery's neglect.

He brought the deplorable situation to the attention of the Bethalto Boys Club - and that was all that was needed.

For last Saturday, armed with youthful energy, a power mower, hatchets to cut down the encroaching trees, and grass clippers, four members of the Boys Club went to work on the cemetery, tidying the plot proper.

Under the leadership of Club Director Danny Smith, the boys included Jerry Rebemeyer, 9; Rick Hill, Gary Sparrowk and Chris Stuzman, all 15.

They were given a helping hand by three adults in addition to the director: John Hill, president of the club; Police Chief Lewis L. Dreith and Loren Miller, both directors of the club.

Also the cemetery gate, which had turned a scaly black, has been freshly touched up with aluminum paint; as has the iron chain separating the Lyons graves within the enclosure; as Wiley Preuitt married Luther Lyons' daughter Martha.

About thirty years ago the Prewitt Farm, which had been acquired by John Nolte, was purchased by Mr. and Mrs. George Balster, 86 and 80 respectively, with the continuing stipulation the burial ground on the property be open to public visiting access.

The Balsters live in a house near the site of the now razed Preuitt homeebead, not far from the family cometery.

In the early days, the plot was protected by an ordinary wire fence to keep the cattle out; around 1922 Bethalto contractors Gus Schulette and Tobe Newmann constructed the present concrete enclosure.

The late Mrs. Pritchett, who was the wife of a doctor at Fairbury, Neb., population now about 5,000, wrote to Mr. and Mrs. Balster she was establishing a trust fund for the perpetual care of the cemetery.

But whether she actually did so or not, the Balsters don't know, for they never heard anything more about any such fund.

The founder of the Preultt clan, Martin, is listed in Brink's History of Madison County, published in 1882 at Edwardsville, as one of the earliest pioneers in this region.

He was a very vigorous man, apparently more interested in hunting and fishing than farming.

Martin Preuitt was born in 1752 in North Carolina; at age 15, with his father and the illustrious Daniel Boone, he made a foray into Kentucky; hunting and fishing and "prospecting for land settlement."

However, the then young Martin returned to North Carolina; and subsequently fought in the Revolutionary War battle of King's Mountain, N. C.

On arriving in Illinois in 1806, he settled on Sands Ridge, about three miles east of Alton.

Martin sired six sons, Isaac, Abraham, Jacob, William, James and Solomon.

Brink's History records that Solomon, youngest of Martin's sons, drove the horse and sled that carried the seven bodies of the Wood River Massacre to their burial places in Vaughn Cemetery about three miles southeast of Bethalto center.

The seven were murdered by marauding Indians, on a Sunday afternoon, July 10, 1814.

They were Mrs. Rachel Reagan and her two children, Elizabeth, 7, and Timothy, 3; Joel Moore, 11, and William Moore, 8, sons of Capt. Abel Moore; and John Moore, 10, and George Moore, 3, sons of William Moore.

After the attack, the Indians split up individually, and James and Abraham Preuitt, sons of Martin, pursued and caught up with one of them, and killed him, and found Mrs. Reagan's scalp on him.

Brink's History related that Solomon Preuitt, who died in 1875 at age 85, "was a history within himself and the pioneer times of Madison County."

Soloman married Rebecca Higgins when she was 17, and she bore him 10 children, three daughters and seven sons, Abraham, Isaac, Jacob, Martin, James, Elizabeth, William, Nancy, Wiley and Mary.

Wiley was the father of Mrs. Pritchett.

In 1811 Solomon was elected captain of a militia company; in 1813-14 he

was a federal Ranger out of Fort Russell; in 1831-32 he fought in the Black Hawk War, serving in a company formed in Milton.

Returning from the war, he was elected a major in the militia - a post he held for many years.

In 1820, Brink's History records, Solomon Preuitt set out about 40 small trees grown from yellow apple seeds, brought here from a Louisianan Fæench settlement.

Thus the Preuitt Family was one of the best known in early Madison County, particularly Martin and his son Solomon.

And this year, after long neglect, their graves and those of other members of the family, are cared for once again.

Thanks both to the anonymous person and the Bethalto Boys Club.

And also, for the first time in a long time, there will be an American flag, come Memorial Day, in place beside Martin's graveside, in tribute to his Revolutionary War service.

For the Bethalto Boys Club has pledged to place the flag there.

The full sheet from the newspaper is in the Museum with ten pictures that were printed, one of Solomon Preuitt.

#### THE FAMILY OF JOSEPH HINDS

#### OF GUILFORD AND RANDOLPH COUNTLES

In 1763 Joseph Hinds bought land on Polecat Creek, Guilford County, N. C. A record shows that he may have been the Joseph in the following; "Orange and Guilford County, 1754, Men commanded by Capt. James Alston: Joseph and John Hines, and Moses Hines." As his son John, by his personal records, shows that he was apprenticed to Robert Carlisle of Rocksburg, N. J. in 1753 it would seem that Joseph migrated between 1753 and 1754. His records also indicate that he probably descended from James Hinds of Salem, Mass., whose descendants migrated to eastern Mass. to Southold, N. Y. to Morris Co., N. J. to N. C. In his will dated 1772 Joseph named his friends as being Isaac Beeson and Jeremiah Reynolds. The latter also settled in Randolph County in 1753 being the son of William and Rachel Reynolds of Orange Co., N. C.

I suspect that the first John Hinds was the one in the following record, "1758 Gates Co. Northern part of Chowan-Western 2/3 part of Gates." Other than this notation I have no record on John or Moses Hines though I suspect that they were closely connected to my Joseph.

Joseph Hinds, Jr. was active in the Revolution being a delegate to the Halifax Convention. He signed his brothers Revolutionary pay vouchers. Another son, Simeon died in the war in 1778.

Son Levi probably was not involved as there is no known record of his participation and no land grant.

The youngest son, Capt. John Henry Hinds, was a typical pioneer. He was a Capt. of Dragcons under Col. Collier and Col. Luttrell. There are a number of accounts of his activities in N. C. State papers. In 1788 he was appointed to form a company to protect the people of Randolph against theives. In 1779 he met at the home of Abram Reese, later owned by Elias Allred, to be elected a Justice for holding court in Randolph Co. Elias Allred served under Capt. John in the war. He was also a commissioner to decide on where to place the new courthouse in the new county in 1779.

By 1790 he had moved to Burke County and then by 1793 to Grainger Co., Tenn. or because of a dispute the land was also for a time in Cumberland Co. Kentucky. In Tenn. State papers (1793) he is shown being appointed to take a flatboat with corn to Chickasaw Bluffs. He had two Indians and two white men on board. A hazardous trip at best. By 1805 he is living on Beaver Creek, Knox Co., Tenn. and called himself a planter. He built a grist mill there on his property. He owned well over 4,000 acres of land situated in Grainger, Knox, Overton, and Roane Co., Tenn. When an elderly man, he had a land dispute in Roane Co. with a much younger man. He settled it by Indian wrestling and it ended in a draw. His will and incentory show that he had a very large and interesting estate with many unusual articles for the area in which he lived. In 1781 he said he owned a blooded mare worth 3200 lbs. Many years ago a Mr. Harry Burn bought at auction a lovely land carved crib and a desk. In refinishing them he discovered a secret drawer in the desk. It was filled with John Henry Hinds' original papers. See "The Journal of N. C. Genealogy 1964 Winter Edition." Also SAR # 1015. Some years leter these papers disappeared. Mr. Burn was President of the SAR and was understandably very upset but fortunately had given a local historian

permission to copy them. He has since attested to their authenticity. I have since proven enough from these records that I, too, believe they must be correct. These papers indicated that Johns cousin was Jacob Baldwin. His brother-in-law was Joseph Seaton and his son-in-law was Francis Mayberry.

Joseph Hinds Jr. did not leave a will but died in Knox Co., Tenn. Levi had moved from Know C. to Roane Co. where he lived on Johns property on White's Creek. After John's death Levi moved to Kentucky where he died in Wayne Co. Levi's children seem to have migrated to this area.

Many of the families whowere with the Hinds in Randolph Co., N. C. seem to have migrated to Roane Co., Tenn, too,
